The LEA will partner with local universities to offer clinical hours to Language and Speech Pathology interns. The interns will work with data, assigning tiers, and assisting with small groups. These supports will be a priority moving forward while ensuring students are engaged and connected to their learning. More emphasis will be placed on students in grades 3-8 who failed to meet mastery on the LEAP2025. Semesterly the SBLC team will review the progress of students based on documentation

from teachers. This will inform continued support offered throughout the following semester or summer.
