3rd -6th graders below proficiency (ITBS) or Basic (LEAP) in English or Math will complete personalized, accelerated tutoring in new Reading/Math Centers. Teachers will use a combination of highly effective resources - IXL math; Go Math; Saxon Math; MathSeed; Mathletics; etc. Similar resources will be used for reading. Small groups will attend (30 m/d, twice/wk) for 6 weeks or until target is reached. Initial, weekly and post assessments will be used to develop study plans, measure progress, and to retain or return student after 6 weeks. Intervention will focus on students' weakest skills on the ITBS, LEAP and DIBBLES (literacy). The overall goal will be to help students achieve Mastery. The Centers will be state-of-the-art learning environments, equipped with Smart Boards, individual chromebooks, printers, internet, wifi, etc. Identified students may also be assigned to Afterschool (2 h/d, 3 d/w); Saturday Academy (4 h/d, 8 m); and, Summer (6 h/d, 5 wk). Two highly qualified math teachers and a university math professor will lead math. Reading will be staffed by well-trained teachers.
