Small group teacher led instruction as well as computer based programs are used to provide the interventions to these students. The regular education teacher, reading interventionist or special education teacher will provide these intervention services for students. Students in grades 6-8 are provided intervention using small group teacher led instruction as well as the READ 180 program. The reading teacher provides these interventions for student. A math interventionist provides intervention services to students in grades 3-8. The interventionist goes in to the math classroom to provide small group instruction as well as provides pull-out instruction using small group teacher led instruction and online Zearn curriculum. These students are also offered after-school tutoring done by regular education and special education teachers in both ELA and Math. Small group teacher led instruction, whole group instruction and computer based instruction are used in after-school tutoring.
