The Louisiana Department of Education received 212 responses from the stakeholder input survey beginning February 6, 2024, as a result of a comprehensive communication strategy that included communication with our state Special Education Advisory Panel, our local school systems, shared communication through our state Parent Training and Information Center and family regional centers, community councils and organizations, and social media communication. The draft application posted publicly March 19, 2024, and public comment will remain open until April 19, 2024 using the same communication strategies and dedicated funding webpage.

1. Describe how your entity's existing mission, policies, or commitments ensure equitable access to, and equitable participation in, the proposed project or activity.

The Louisiana Department of Education (LDOE) is driven by a mission centered on getting the best outcomes for all students who call Louisiana home. It is our vision that every child can reach their potential, no matter where they live or how much money their family makes. Louisiana will get there by giving all students the opportunities and tools they deserve, so they are prepared to graduate high school ready for a career or college. Our vision for Louisiana students is ambitious and attainable, with six critical goals that outline a student's successful progression from birth through graduation.

Together with our educators, leaders, community members, and families, it is our responsibility to make sure every student 1) enters kindergarten ready; 2) exits third grade reading on-level and ready for fourth grade; 3) exits eighth grade ready for success in high school; 4) graduates on time, 5) earns a college credit or career credential; and 6) is eligible for a Louisiana scholarship. To help us work towards achieving our six critical goals, we have established six education priorities. Each priority includes projects and initiatives in support of the six critical goals. By targeting our resources to support work around these priorities, we will stand up the highest-impact work to improve outcomes for all Louisiana children. The priorities encompass all students, including students with disabilities, and aim to remove barriers and create inclusive learning experiences so every child can access the educational environment that best meets their needs.

Louisiana state law outlines the LEA's responsibilities for providing for the education of students with exceptionalities within their jurisdiction, which requires LEAs to implement policies, procedures, and programs that are consistent with state policies and procedures. Louisiana's state Special Education Advisory Panel (SEAP) is established in accordance with the requirements of the Individuals with Disabilities Education Act (IDEA) 2004 Sec. 612 and provides policy guidance with respect to special education and related services for children with disabilities in Louisiana. Furthermore, state law requires that each LEA establish a special education advisory panel to provide advice and feedback regarding special education policies, procedures, and resources. The council shall also engage in outreach activities to the community at large to increase the level of knowledge, support, and collaboration with respect to special education.

Additionally, the LDOE makes positive efforts to partner with, employ, and advance qualified individuals with disabilities in project activities described in Section 606 of IDEA. The Louisiana

Department of Education does not discriminate on the basis of gender, race, national origin, color, disability, or age, and it complies with all state and federal laws and regulations concerning non-discrimination as described in Section 427 of the General Education Provisions Act (GEPA).

2. Based on your proposed project or activity, what barriers may impede equitable access and participation of students, educators, or other beneficiaries?

Louisiana has 1,371 schools in 199 school systems across the state. Louisiana serves 681,176 students, 72.5% of whom are economically disadvantaged; 5% are English Learners and 13.8% receive special education and related services.

Louisiana's most recent educator workforce report indicates that although special educators are not in our top three needs of our educator workforce vacancies statewide, special education is a top-five area of need. Louisiana continues to be committed to ensuring students have high-quality, qualified educators to support them.

Our most recent SPP/APR and state achievement data for students with disabilities continue to show learning recovery and improvement, but the achievement gap between students with disabilities and their non-disabled peers persists.

3. Based on the barriers identified, what steps will you take to address such barriers to equitable access and participation in the proposed project or activity? During the 2017 Regular Session, the Louisiana Legislature passed Act 224, which became R.S. 17:22(11), requiring the State Superintendent of Education to annually prepare and submit a report that assists policymakers and the public in assessing the extent to which Louisiana students have access to a quality public education. The law requires the report, at a minimum, contains school-level information relative to the following:

- Enrollment in various types of schools: type of school and percentage of students who are economically disadvantaged, indication of an Individualized Education Program plan or Individualized Accommodation/504 plan, percentage of racial or ethnic minorities, and percentage of English learners.
- Academic achievement and educational attainment: state test scores, student completion numbers of courses required for TOPS, and the attainment numbers of college credit and industry-based certifications.
- Access to the arts and world languages: percentage of students receiving instruction in the arts and in other languages, including students enrolled in world language immersion programs.
- Out-of-school discipline: percentage of students suspended or expelled
- Access to educators: percentage of "Highly Effective" teachers and number of teacher absences.

LDOE will continue to work alongside our Recruitment and Retention Taskforce to ensure we have educators with the knowledge and skills to support our students with disabilities in high-quality, inclusive teaching and learning, and will put forth policy and procedures to support this.

Despite academic progress for our students with disabilities, the performance of students with disabilities in Louisiana lags behind that of other students. Louisiana has adopted best

instructional practices to support students with disabilities and will continue to encourage all educators – from school system leaders and principals to classroom teachers – to embrace policies and practices that guarantee high-quality educational experiences for these learners.

LDOE will also continue to emphasize the importance and support of input from parents and stakeholders in project activities.

4. What is your timeline, including targeted milestones, for addressing these identified barriers?
LDOE analyzes data throughout the year to assist in determining how to direct funds in alignment with the current state-level activities and to develop guidance and technical assistance to address specific trends in the data. The Special Education Advisory Panel meets approximately five times a year to address these issues. Activities are designed to address current barriers and prevent future barriers from impacting students with disabilities in accessing a free and appropriate public education. LDOE’s annual state performance plan/annual performance report include performance milestones aligned to activities.
