

2019 – 2020 Fall and Summer Operational Results: Supplement to the 2018-2019 LEAP 2025 High School Operational Technical Report: English I, English II, Algebra I, and Geometry

Reason for Supplement

School closures due to COVID-19 affected the administration of the 2019–2020 LEAP 2025 High School (HS) tests. The tests were administered as planned in December 2019; however, Louisiana received approval from the federal and state governments to waive the requirement to administer the spring assessments due to school facilities closing in March 2020. Although the summer administration occurred, it was postponed until July 2020, and fewer students than prior summer administrations participated as shown in Table 1, which compares the student count from the 2018–2019 and 2019–2020 fall and summer administrations.

Typically, a technical report contains information regarding the development of items and forms as well as the operational results of the administrations. Since the spring 2020 administration was cancelled, there is nothing to report regarding the development and results of the spring 2020 forms. Additionally, item and form development activities for the forms used in fall 2019 and summer 2020 were already documented since they are intact forms that were constructed according to the guidance in the 2018–2019 technical report. Due to these circumstances, the decision was made to forego a traditional technical report and document the operational results of the fall 2019 and summer 2020 administrations in this supplement to the 2018–2019 LEAP 2025 High School Operational Technical Report. The tables included in this supplement are the tables that would exist in a stand-alone technical report if it was produced.

When reviewing the reported results, it is important to note that the fall administration includes initial testers who are on a block schedule as well as retesters, while the summer administration is primarily retesters. When a table includes only fall administration results, it is because it is appropriate to report those results based only on initial testers. Since there are few initial testers in the summer administration, summer results were not always reported. For ease of reference to the 2018–2019 technical report, each section and the table numbers in this supplement coincide with what they would be if a full technical report was produced. At times they will seem to skip a number or chapter, and that is due to not having spring results to report.

Executive Summary

Table E.1 presents the percentage of students in 2019–2020 who were classified in each of the achievement levels for each subject test. In general, students testing in the fall are a mix of initial testers on block schedule and retesters, while students testing in the summer are primarily retesters.

Test Administration (Chapter 4)

Tables 4.2 and 4.4 summarize accommodations information for the 2019–2020 LEAP 2025 HS administrations. The analyses are based on census data and include only those students who received accommodations or designated features and received a scale score on the ELA or Mathematics LEAP 2025 HS assessments. The percentage represents the percentage of the census population receiving that accommodation or designated feature. Scoring of Constructed-Response and Technology-Enhanced Items (Chapter 5)

The tables that follow present scoring information for the ELA and Math constructed-response items. Some of the ELA items across English I and English II (noted in Table 5.1) were scored by an AI engine, Pearson’s Intelligent Essay Assessor (IEA), using scoring models previously developed by Pearson.

A minimum of 10% of the constructed responses in ELA and mathematics were scored independently by a second reader. This was the case regardless of whether the first reader was human or AI. The statistics for inter-rater reliability were calculated for all items at all grades. As shown in Tables 5.8 and 5.10, raters demonstrated at least 99% perfect and adjacent agreement for all ELA handscored items. As shown in Tables 5.11 and 5.13, raters demonstrated 100% perfect and adjacent agreement for mathematics items. As shown in Tables 5.14 and 5.16, raters demonstrated 100% perfect and adjacent agreement for Spanish mathematics items.

Operational Data Analyses (Chapter 6)

The tables that follow present information about the different analyses that were conducted on the operational data. Table 6.1 presents the number of items, score points, mean and standard deviation of the raw scores, and the average form difficulty of each subject test for each administration. Form difficulty for a student was calculated by dividing the student's raw score by the total score points of the test.

Table 6.2 presents the number of items, mean and standard deviation of the item p -values, and item-total correlations (i.e., item discrimination values) of each subject test for each administration.

The p -value is a measure of item difficulty and the mean p -value, in the table, is the average of all item p -values for a specific subject test and administration. An item-total correlation is the correlation between an item score and the total test score, where the item score is not included in the total score. The mean item-total correlation (R_{it}), in the table, is the average of all item point-biserial correlations of a specific subject test.

Test Results (Chapter 7)

The “Attempted” category includes all the students who attempted at least one item on the assessment, and the “Reportable” category includes students who finished all sections of the assessment; the numbers for both of these categories include all students in public schools as well as students in private schools and home-study programs. The “Technical Report Sample” category represents the sample of students included in the analyses for this report, and they are the students who finished all sections of the assessment and counted toward the state total score; students in private school and home-study programs were excluded from this sample.

Evidence of Construct-Related Validity (Chapter 9)

Results reported in this section are based only on initial tester data; therefore, summer results are not included.

Total test reliability measures, such as Cronbach’s coefficient alpha and standard error of measurement (SEM), consider the consistency (i.e., reliability) of performance over all test questions in a given form, the results of which imply how well the questions measure the content domain and could continue to do so over repeated administrations. The reliability coefficients for the fall LEAP 2025 HS assessments are reported in Table 9.2. English I and English II have one writing component (RI or RL) that has the same score as another component (WE). The item score for the RI/RL writing component was excluded from the reliability computation.

The item response theory's (IRT) unidimensionality assumption was evaluated through principal components analysis (PCA). This analysis seeks evidence that there exists a single primary factor, the first principal component, which accounts for much of the relationship between items. The presence of a single or dominant factor suggests that a test is sufficiently unidimensional (i.e., that it measures one underlying construct).

For the LEAP 2025 HS ELA and mathematics assessments, the ratio of variance accounted for by the first factor to variance accounted for by the second factor is sufficiently large to indicate that the unidimensionality assumption holds. All the LEAP 2025 HS ELA and mathematics tests exhibit first principal components accounting for more than 20% of the test variance (Tables 9.8–9.11).
