Purpose

This calendar provides an overview of the statewide assessments and screeners required by federal law, state law, or the rules of the Louisiana Board of Elementary and Secondary Education (BESE) for the 2026–2027 school year. Assessments are organized by grade band to help educators, families, and school systems locate key information about each assessment. [Act 674 \(2026\)](#) requires each public school governing authority to post a direct hyperlink to this statewide assessment schedule and a PDF copy of the schedule on its public website no later than ten business days after the Louisiana Department of Education (LDOE) posts or updates the schedule.
