Course Description

This course is an exciting new Louisiana Jump Start initiative that combines the former Entrepreneurship curriculum with a new industry based credential focusing on small business operations. Louisiana high schools are implementing the new Micro-Enterprise Credential sponsored by the Baton Rouge Area Chamber (BRAC) and supported by Chambers of Commerce across the state. The goal of the Micro-Enterprise Credential is to help students learn the behaviors and skills necessary to succeed as a small business employee and (one day) as a small business owner/entrepreneur.

Micro-Enterprise is a **Secondary** credential that is essential to the Jump Start Pathway offered at Hahnville High School. Upon completion of this course, students will have had the opportunity to earn **one Secondary** credential. In the event that the student does not choose the Jump Start Pathway to Graduation, this credential is an excellent addition to any resume. In addition to the course content, literacy skills are embedded throughout the curriculum. Reading, Writing, Speaking, Listening, and Problem Solving Skills will be reinforced in daily activities and through workplace simulations.
