





# **Updates to the Louisiana Comprehensive Literacy Plan**

- Added new policies
- Single Universal Screener three times per year using full composite
- Multi-Tiered System of Support
- Dyslexia
- Professional Learning, including new Louisiana Professional Learning Platform - Building capacity for sustainability
- Disseminating CLSD best practices across the state
- Tagging grade bands, specifically adolescent literacy
- Connect to professional learning structures, such as ILT and Teacher Collaboration

## VI. Consideration of an update on Act 422: Third Grade Retention Guidance



### **Act 422: Third Grade Retention**

Prohibits promotion to the fourth grade of certain students whose reading deficiencies have not been remediated by the end of the third grade.

- Does not include charter schools
- Literacy screening
- Individual reading plan
- Exceptions for good cause
- Required instructional services to retained students



### **Act 422: Third Grade Retention**

Third grade students who have not met such an acceptable level of performance may be retained or promoted (good cause promotion); but in either case shall be provided with an **individual student literacy plan** that adheres to the following requirements:

- daily targeted small-group interventions
- before and after school literacy intervention provided by a teacher or tutor with specialized literacy training
- at-home literacy programs that include literacy workshops for the parents and legal guardians of students
- web-based or parent-guided home literacy activities
