# Early Childhood Education Re-Review Status Report

Re-Evaluation of Current Tier 1 ECE Materials for ELDS 2025 Alignment

## Early Childhood Education Overview

The LDOE updated [Louisiana's Early Learning and Development Standards \(ELDS\)](#) and released the updated [2025-2026 IMR Rubric - ECE, Ages Birth to Five](#). As part of the LDOE's support for a seamless transition to instructional materials that align with the Louisiana ELDS, publishers with currently posted Tier 1 ECE materials must re-submit materials for evaluation to maintain a Tier 1 rating. If publishers have an updated version of the Tier 1 materials, the new version may be submitted in place of the original version.

This report includes the status of all current Tier 1 ECE programs. Publishers can submit materials for review beginning August 18 through September 2. If publishers of Tier 1 reviews do not submit materials for review by September 2, the materials will **no longer be considered Tier 1**, and the review will be added to the [Not Reviewed for Alignment to the 2025 ELDS](#) section of this report.
