- 4. I will disclose web-based accessibility levels.**
- 5. I will disclose technology requirements needed to operate the program(s) submitted.**
- 6. I will not directly contact the experts assigned to review my instructional materials.**
- 7. I understand that the Louisiana Department of Education makes all final standards alignment decisions and associated rankings.**
- 8. I understand that I may be notified of major changes to rubrics and will be given an opportunity to proceed with state review using the new rubrics.**
- 9. I understand that there is no appeals process to the final reviews, but I will have an opportunity to respond to the reviewer comments within the timeframe designated or forgo my opportunity to respond.**
- 10. I will provide parents and other members of the public with authorized web access⁶ to my student editions and understand that public comments related to the products under review will be published as part of the review.**
- 11. I understand that the Department will not verify the accuracy or validity of public comments and that these public comments do not reflect the opinions or policies of the State Board of Elementary and Secondary Education or the State Superintendent of Education.**
- 12. I will provide my company registration number that I obtained from the Louisiana Secretary of State or my Federal ID, which allows me to do business in the State of Louisiana. I must have copyright privileges to submit materials for review.**
- 13. I am an officer of the firm legally authorized to act on behalf of the publisher and properly certify that all data is complete and correct.**

14. I will have an opportunity to enter into a contract with the Department for my materials that receive a Tier 1 or Tier 2 rating.
