

Data Sharing Agreement Addenda Submission

This is a list of the data sharing agreements that are applicable to school systems. The agreements, by way of addenda, allow individual school systems to opt in, so that they may also receive the services provided and protect the privacy of their students. All executed <u>LDOE data sharing agreements</u> are posted in full on the LDOE website.

This chart is a tool to assist in determining what agreements your school system needs to opt into and next steps.

- 1) Review the purpose of each agreement and determine if this agreement is needed in your school system.
- 2) If the agreement is needed,
 - a. Confirm your school system has opted into the agreement by reviewing the <u>Data Agreement Tracker</u> using GOOGLE CHROME or MICROSOFT EDGE or <u>tracker</u> if using another browser. The "Notes" will indicate if the LDOE has received the agreement or not.
 - b. If the LDOE has received the agreement, no further action is needed.
 - c. If the LDOE has not received the agreement, review the agreement using the "Download Link" for that specific agreement, download, sign, scan, and submit the signed document via the "Submission Link"
