CONSENT ORDER


This matter was set for a hearing on the State's request for a preliminary injunction to halt the operation of an unlicensed "Child day Care Center" or "Early Learning Center". Prior to the hearing, the parties reached an agreement and now enter into this Consent Order on the following terms:

1. Defendant, **JESSICA ADDINGTON** does consent to the issuance of a preliminary injunction prohibiting her, agents, from operating a child day care facility without a license;
2. In recognition of **JESSICA ADDINGTON** cooperation, the State waives its request for statutory fines and penalties so long as **JESSICA ADDINGTON** comply with this order;
3. **JESSICA ADDINGTON**, does agree to allow the Louisiana Department access to the facility as necessary to conduct site visits in compliance with state and federal guidelines.

THEREFORE, IT IS ORDERED, that a preliminary injunction issue, directed to defendants **JESSICA ADDINGTON**, and enjoining, restraining and prohibiting her, her officers, agents, employees, representatives, and all others acting at her direction or on her behalf, from operating a child day care facility without a license; this preliminary injunction to be effective during the pendency of these proceedings;

IT IS FURTHER ORDERED, that the state hereby waives the statutory fines and penalties sought in its petition, contingent upon Defendants compliance with this Order;


