2015-2016 Learning Year Lead Agency Expectations

Purpose

- Lead Agencies will be funded to coordinate 2 key functions: observation and enrollment
- Are **not** responsible for licensing, producing performance profiles or deciding funding

Specific Responsibilities

Coordinated Enrollment	 Lead planning and implementation of coordinated enrollment Submit community application for funding to State/Feds Apply to participate in Preschool Development Grant
Coordinated Observation	• Wunuqiing schedule so each classi oonn receives at reast two CLASS observations by remable observer

Funding

- \$5M for observations, start-up funds and expansion funds in 2015-2016
- Lead Agencies may also leverage existing funds (e.g. LA 4, Head Start, PreK Grant)
- R & Rs, not Lead Agencies, are responsible for training and coaching for child care

Key Milestones

September 11

Submit observation schedule and plan for fidelity and reliability

November 16 Submit Coordinated

Enrollment Plan (Cohort 1/2) December 15

Ensure 100% of classrooms are observed in the fall with accuracy January 15 Submit Coordinated Enrollment Plan (Cohort 3)



Bulletin 140 Guidance Coordinated Observations Expectations

As established in Bulletin 140, Lead Agencies are expected to submit a written annual plan for coordinated observation that includes:

- The number of *CLASS* observers who will conduct observations;
- The total number and the location of toddler and PreK classrooms that must be observed;
- An observation schedule that includes one fall and one spring observation for each toddler and PreK classroom; and
- A plan to ensure reliable data that includes the following requirements:
 - All observers are reliable
 - All observers maintain inter-rater reliability and fidelity
 - Network conducts inter-rater reliability observation checks for 10 percent of all classroom observations
 - No conflict of interest exists

The CLASS Observation Plan Template captures all of these elements in one place. These plans are due to the Department in September.

Bulletin 140 Guidance *CLASS* Observation Plan Template

Planning and scheduling your CLASS Observations will occur in two steps:

- The *CLASS* Observation Plan is the first step in formalizing your plan to observe all classrooms twice.
- The completed CLASS Observation Plan will inform data entry into the CLASS system, which will be released in the fall.

The *CLASS* System will be used to communicate observation schedules in real time. Results of observations will be submitted through the *CLASS* system.

CLASS Observation Plan	CLASS System
• The <i>CLASS</i> Observation Plan has been sent to Lead Agencies, prepopulated with site codes and site names.	• Each site will enter into the <i>CLASS</i> system all of their classrooms.
 Lead Agencies will enter into the CLASS Observation Plan all of the classrooms/teachers. 	• Observers will submit the results of all observations in the <i>CLASS</i> system no more than ten days after an observation.
• Lead Agencies will schedule all observations in the <i>CLASS</i> Observation Plan for the entire year in September.	• Sites will adjust their classroom counts in the <i>CLASS</i> system in February based on any changes.

The CLASS Observation Plan will be compared to what is in the CLASS System to ensure Lead Agencies are on track to observe and report all CLASS Observations.

CLASS Observation Plan Template Tab 2: Observation Plan

- Your Observation Plan ensures that you are meeting the requirements of B140.
- Each answer should be 500 words or fewer.

Questions	Plan (500 words or fewer for each)
What is the plan to ensure that all observers are reliable? Reliability is defined as observers having a certification achieved by completing and passing all trainings and assessments required by Teachstone to conduct a CLASS observation with validity and fidelity.	
What is the plan to ensure that all observers maintain inter-rater reliability and fidelity? Inter-rater reliability occurs when two or more observers produce consistent observation results for the same classroom at the same time.	
What is the plan to ensure that no observer conducts an observation in a classroom in which the observer has a conflict of interest? A conflict of interest may exist in, but is not limited to, situations in which the observer: supervises, provides training or technical assistance to, or is an immediate family member of a teacher in the classroom being observed or has a direct financial interest in the site where

- The schedule is the first step in formalizing your plan to observe all classrooms twice.
- Most boxes will be prepopulated lists from Tab 3. You will select the information rather than type it every time.
- Data entered here will populate the right side of the **cover sheet**, as a check to ensure all classrooms are observed twice and 10% of observations are shadow scored.
