Key Activities in Quarter 2 Early Childhood Accountability System

The Department and Community Network Lead Agencies (CNLAs) continued to support local sites to implement the early childhood accountability system.

Community Network Lead Agencies (CNLAs) completed Spring CLASS® observations in April-June:

- CNLAs coordinated more than 3,000 CLASS® observations, observing more than 58,000 minutes of early childhood instruction inclusive of:
 - 510 Infant CLASS® observations,
 - 1,037 Toddler CLASS® observations, and
 - 1,505 Pre-K CLASS® observations.



Key Activities in Quarter 2 Early Childhood Community Networks

The Department and Community Network Lead Agencies (CNLAs) worked together to close out the 2022-2023 academic year.

As part of close-out activities for the 2022-2023 academic year:

- Teachers completed the third and final checkpoint for Teaching Strategies GOLD® in May 2023.
- CNLAs observed more than 500,000 minutes of care in the spring observation period between January and June 2023. This included more than:
 - 1,100 infant observations,
 - 2,100 toddler observations, and
 - 3,600 pre-K observations.




Key Activities in Quarter 2 Early Childhood Community Networks

Community Network Lead Agencies (CNLAs) successfully improved enrollment and access by increasing family engagement and outreach programs.

CNLAs are improving enrollment by implementing strategies such as:

- Creating more robust public awareness campaigns using a multimedia approaches (e.g., TV, print, geographical social media campaign, etc.).
- Hiring a marketing firm to promote the community network's mission and enrollment.
- Providing informational campaigns to inform families of young children with disabilities, children whose home language may not be English, and children experiencing homelessness about finding a placement that best accommodates their needs.
- Improving community outreach by increasing network presence at community events (e.g., community celebrations, library events, health events).



Key Activities in Quarter 2 Early Childhood Community Networks

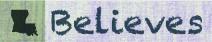
The Louisiana Legislature invested more than ever in early childhood care and education, enabling the Department to allocate funding for the 2023-2024 CCAP B-3 Seats Pilot program.

The B-3 Seats pilot began in 2020-2021 and was projected to end as of June 30, 2023, prior to State investment.

By the close of Quarter 2 and the 2022-2023 academic year, B-3 Seats were serving 3,560 children across 30 networks:

• 553 Infants, 811 one year olds, 1,025 two year olds, and 1,171 three year olds.

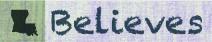
The Department is currently developing strategies that will transition the original B-3 Seats pilot into a permanent program with sustained funding. This work will codify the CCAP B-3 Seats Pilot program into policy and formally incorporate it into Louisiana's CCDF State Plan.



Key Activities in Quarter 2 Early Childhood Education Fund

The Louisiana Department of Education allocated funding to seven Community Network Lead Agencies that raised qualifying local funds for the Early Childhood Education fund.






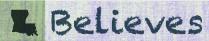




Key Activities in Quarter 2Ready Start Networks

Ready Start Networks are committed to a unified effort to promote high-quality ECE and increase access at the local level.


- In May 2023, 5 Ready Start Networks began participation in a Preschool Development Grant (PDG) Workforce Planning SubGrant to study local-level data related to workforce development, recruitment, and retention.
- Another 5 Ready Start Networks began participation in a PDG Family Engagement and Leadership grant to promote family engagement initiatives at the network level through:
 - robust communication strategies to expand family engagement,
 - the leadership development of parents, and
 - sharing of best practices that most effectively prepare children for success in school and beyond.



Key Activities in Quarter 2 Supporting Teachers to Be Successful

The Department continued to provide professional development opportunities for child care teachers across the state.


- 17 BESE-approved Early Childhood Ancillary Certificate (ECAC) Programs
 provided course content, coaching, and support focused on preparing teachers
 for successful classroom interactions during this period.
- Child Care Resource and Referral (CCR&R) agencies conducted training and coaching that:
 - focused on Instructional Support and Engaged Support for Learning, and
 - targeted sites with overall scores in the Approaching Proficient range and classrooms with new teachers and/or low scores.
- CCR&R agencies provided a total of 4,044 hours of coaching and 617 hours of training. These agencies also provided 375 hours of coaching to 87 Family Child Care sites across the state that have opted into Academic Approval.



Key Activities in Quarter 2 Supporting Teachers to Be Successful

The Department supported teachers and leaders to support young children with disabilities by providing training and materials to networks for the administration of developmental screening.

- Community Network Lead Agencies reported that 86% of networks administered a universal developmental screener to 18,122 publicly-funded pre-K children in school-based settings across the state.
- The Department presented sessions at the 2023 Teacher Leader Summit and Early Childhood Conference to improve outcomes for children with disabilities. Sessions included the following:
 - **Promoting Inclusion in Early Childhood** This session provided the field with information on creating inclusive environments, how inclusion impacts child achievement, and supporting children with disabilities in inclusive environments.
 - Accelerating Learning in Early Childhood Settings This session provided the field with information on accelerating learning in early childhood by embedding high-quality instruction within the learning day to maximize success for all children.
- The Young Children with Disabilities Community of Practice provided training to early childhood administrators to improve child outcomes and data hygiene practices when using TS GOLD®.



Key Activities in Quarter 2 Supporting Teachers and Directors to Be Successful


The Teacher Leader Summit took place May 30 - June 1 and the Early Childhood Conference took place on June 2 - 3 at the Morial Convention Center in New Orleans.

More than 750 early childhood professionals attended the 2023 Teacher Leader Summit, which included 71 early childhood sessions on topics such as:

- Using the Data Cycle to Increase Program Quality,
- · Language and Literacy in the Preschool Classroom, and
- Engaging All Families in the Community.

Approximately 2,000 teachers, leaders, and staff attended the 2023 Early Childhood Conference:

- Along with two days of high-quality sessions, there were opportunities to network with colleagues and recognize excellence across the state.
- Early childhood professionals learned how they can make the most of their time teaching and supporting children during the conference.

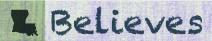


Key Activities in Quarter 2 Supporting Directors to Be Successful

The Department is supporting child care directors meet standards for high-quality learning, leadership, and business practices.

The Department supported directors by:

- Providing outreach, support, and monthly webinars for new directors;
- Launching intensive technical assistance efforts for the transition of the CCAP attendance tracking system from TOTS to KinderConnect, including site visits to assist sites in finalizing set up of the new system;
- Providing one round of ARPA Stabilization grant funding for more than 1,300 providers for more than \$63 million, and opening an application for a final round of grant funding;
- Awarding Early Childhood Teacher and Leader of the Year 2024 Award winners at the 17th Annual Cecil J. Picard Educator Excellence Awards Gala; and
- Offering Cohort 4 of the <u>Louisiana Early Leaders Academy</u>, providing participants with leadership development, systems thinking training, and collaboration with peers to strengthen their business practices.

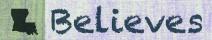


Key Activities in Quarter 2 Child Care Assistance Program (CCAP)

The Department has supported child care providers and families through the Child Care Assistance Program (CCAP).

- The Department transitioned to KinderConnect as its mandatory attendance tracking system for all CCAP families in April 2023.
- KinderConnect is a web-based provider portal that saves time spent on administrative tasks while minimizing the possibility of fraud.
- The transition to KinderConnect is the beginning of implementation of a new, more simplified application process for families and payment process for providers..

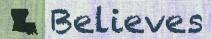


