CONSENT ORDER

This matter was set for a hearing on the State's request for a preliminary injunction to halt and block the operation of an unlicensed "Child Day Care Center" or "Early Learning Center" on September 16, 2020. Prior to the hearing, the parties reached an agreement and now enter into this Consent Order on the following terms:

- 1. Defendant, **NIKKIE PENN**, including her officers, agents, employees, representatives, and all others acting at her direction or on their behalf, each consent to the issuance of a preliminary injunction prohibiting her, and her agents, from operating a child day care facility without a valid license;
- 2. In recognition of Defendants, **NIKKIE PENN**, cooperation, the State waives its request for statutory fines and penalties so long as **NIKKIE PENN**, complies with this order;
- 3. **NIKKIE PENN**, agrees to allow the Louisiana Department access to the facility as necessary to conduct site visits in compliance with state and federal guidelines.
- 4. Defendant will be assessed with all costs associated with this matter.

THEREFORE, IT IS ORDERED, that a preliminary injunction issue, directed to Defendant,
NIKKIE PENN including her officers, agents, employees, representatives, and all others acting
at her direction or on their behalf, enjoining, restraining and prohibiting her, her officers, agents,
employees, representatives, and all others acting at their direction or on her behalf, from
operating a child day care facility without a valid license; this preliminary injunction to be

effective during the pendency of these proceedings;

IT IS FURTHER ORDERED, that the state hereby waives the statutory fines and penalties sought in its petition, contingent upon Defendant's compliance with this Order;

IT IS FURTHER ORDERED, that NIKKIE PENN, consistent with this Order, does allow the Louisiana Department of Education, Division of Licensing, access to any facility as necessary to conduct site visits in compliance with state and federal guidelines.

IT IS FURTHER ORDERED that all costs associated with this matter will be assessed against Defendants;
