

Introduction

The Louisiana Department of Education (LDOE) provided oversight to sub-grantees offering after school services to students during the 2016-17 school year through the federally funded 21st Century grant. Thirty-seven entities provided services to 116 schools and 10,100 students out of the original 130 schools. This report provides a description of the number of programs, level of attendance, and academic performance indicators using the Louisiana Afterschool Framework.

Evaluation Design

The evaluation was based on a cross-sectional design, using descriptive program and participant data provided by the LDOE. These data, collected during the 2016-17 school year, were utilized to assess program impact along with the Louisiana Afterschool Framework to evaluate after-school programs.

Evaluation Components

Using LDOE's Framework for evaluating after-school programs, the evaluation focused on three components to assess provider performance: 1) academic performance; 2) program attendance; and 3) stakeholder satisfaction. Letter grades are assigned based on the total number of points accumulated in all three areas.

Methods

Data Sources

The LDOE analytics team provided the final academic performance points for English Language Arts and math using two data sources: 1) the statewide Student Information System (SIS) (academic performance data for English Language Arts (ELA and Math). and 2) the Youth Services database information on attendance, type of program activities, and content areas. In 2014-15 LDOE created three new Stakeholder Satisfaction Surveys for students, staff and parents that were administered by a small sample of programs as a pilot test. The new Stakeholder Satisfaction Survey results were administered to provide data for the 2015-16 and 2016-17 school year reports. A fourth data source, a telephone interview, was used to provide more in-depth information about how successful programs implemented their after school program.

Measures

Academic Achievement

LDOE measures the academic performance of Louisiana's 21st CCLC programs by the percent of students within each program who exceed their growth target on the state assessment. The

academic performance calculation involves multiple iterative phases integrating a comprehensive database housing descriptive program and participant data. The LDOE analytics team provided the academic performance calculation to establish the average percent of students exceeding their growth target for ELA and math. Points were calculated using the algorithm created by LDOE.

Attendance

LDOE provided data obtained from the Youth Services database to determine the number and percent of regular after-school attendees. Attendance was calculated by using the number of regular attendees and dividing by the projected attendance at the beginning of the year for each program. Points were assigned from 0 to 35 for eight ranges of the percent of projected attendance. For example: less than 15% of projected attendance is assigned zero points and 90% or more of projected attendance is assigned 35 points.

Stakeholder Satisfaction

2016–17 Stakeholder Satisfaction points were calculated by using survey completion rates from provider, teacher, and parent surveys. Points were assigned from 0 to 15 for four ranges of survey completion rates. For example, zero points were assigned to the completion range less than twenty-five percent and 15 points were assigned to the completion rate of seventy-five percent or more.

Qualitative Data

Eleven programs that scored an A grade in the 2016-17 school year were invited to participate in a telephone interview about the practices that their programs were implementing. Ten interviews were conducted with program directors. Interview Questions were based on previous research identifying best practices for successful after school programs in terms of program structure, student engagement, instructional strategies, and issues of accountability. Practices identified through research for successful afterschool programs:

- strong leadership and established clear goals
- aligned program structures and contents to meet goals
- a schedule that allowed time for students to learn and practice
- established relationships with the day school
- curriculum in general reflected a linkage to standards
- research-based strategies
- maintained some form of evaluative structures
- staff members had low turnover rates

- staff members related well to the students
- staff were able to build rapport, maintained high expectations, kept students motivated and engaged

Recommendations

The results suggest that the majority of programs are providing services that keep students engaged and attending the after-school programs. Recommendations for program improvement are as follow:

- Continue to emphasize the importance of addressing academic performance.
 - Provide professional development to staff on standards-driven approaches
 - Provide learning opportunities that address multiple learning modalities
- Work with programs to ensure Stakeholder Satisfaction Surveys are distributed and completed by all three groups of stakeholders.
- Continue to review and implement “best practices” for successful after-school programs. For example:
 - Provide opportunities for staff development and make efforts to ensure all staff are involved
 - Share information to promote parent involvement
 - Connect with the community
 - Build relationships with students; offer opportunities for meaningful participation at school; ensure teachers and program staff convey high expectations for all students.
- Continue to emphasize the value in working with external evaluator to improve programs.
