I am writing to request a waiver, pursuant to section 8401 of the Elementary and Secondary Education Act of 1965 (ESEA), of the following requirements as a result of ongoing challenges related to the novel Coronavirus Disease 2019 (COVID-19):

I am requesting this/these waiver(s) because it is not possible to obligate funds on a timely and responsible basis.

Consistent with the requirements of ESEA section 8401(b)(1)(C) and (F), describe how the waiving of such requirements will advance student academic achievement and how schools will continue to provide assistance to the same populations served by programs for which waivers are requested.


We are requesting these waivers because it is not possible to obligate funds on a timely basis as originally planned, due to student instructional interruptions in response to COVID-19 pandemic. Our state is encouraging all school systems to obligate all COVID-19 relief funding within the required time lines to continue implementing mitigation protocols and to address student learning loss across the state. Instructional loss presented unique student learning challenges thereby increasing the need to provide evidenced based instructional strategies to support learning loss and to provide educators with targeted professional development. This waiver will provide continued support to the statewide instructional focus areas that include literacy, stem, and college and career activities. The state has already witnessed positive gains regarding student learning loss recovery efforts.

- The SEA will use, and ensure that its subgrantees use, funds under the respective programs in accordance with the provisions of all applicable statutes, regulations, program plans, and applications not subject to these waivers.

- The SEA has provided the public and all LEAs in the State with notice of, and the opportunity to comment on, this request by posting information regarding the waiver request and the process for commenting on the State website in the manner in which the SEA customarily provides such notice and opportunity to comment and has enclosed with this waiver request any comments received and a description of how the SEA addressed such comments.
