# What is a Chronic Health Condition?



### **Definition**

The CDC defines Chronic Health Conditions as "conditions that last 1 year or more and require ongoing medical attention or limit activities of daily living or both".





## **Common Chronic Health Conditions**

What are some common chronic health conditions seen in schools?





### **Common Chronic Health Conditions**

- Diabetes
- **Asthma**
- Seizure disorders
- Food Allergies
- Obesity
- Inadequate dental health



#### **Diabetes**

- Under age 20, 1 in 400 individuals are estimated to have Diabetes.
- Approximately 352,000 individuals have been diagnosed.
- 1,952 children on Louisiana Medicaid were diagnosed with Diabetes in 2019.



# R.S. 17:436.3

#### Highlights of the Law:

- Parent to provide from student's Health Care Provider a Diabetes
  Management Treatment Plan
- The school RN shall provide care to the Diabetic student
- Unlicensed Diabetes Care Assistant (UDCA) definition and training
- Student's self management of Diabetes
- Providing information about Diabetic Student to bus drivers and person's supervising during off campus activities
- Liability for school employees





### **Asthma**

- Approximately 6.7% of school age children have Asthma
- 7.2% of Louisiana students have Asthma
- Asthma is more common in males than females

#### Highlights of the Law:

- Parent is to provide child's healthcare provider prescription
- Parent to provide properly labeled medication
- Parent to sign consent
- School RN is to develop an Individual Health Plan (IHP) and an Emergency Action Plan
- Provider to authorize student to self administer and self carry of Asthma medications
- Allows for school RNs to have Trained Unlicensed School Employees (TUSE) administer medications
- Liability for school employees



# **Asthmatic Student Challenges**

- Missing school due to Asthma Attacks and doctor appointments
- Difficulty in participating in physical activities
- Falling behind in school due to missed days
- Anxiety and Stress
- Difficulty in Managing Medications
- Lack of awareness by teachers and staff and sometimes parents





### **Seizure Disorders**

- Approximately 456,000 children 17 and under have an Epilepsy diagnosis.
- It is estimated that 7,900 children in LA have a seizure disorder.
- Students can have a seizure disorder and not have Epilepsy.
- There are two types of Seizures, Focal and Generalized.



### R.S. 17:436.4

#### Highlights of the Law:

- Parent can submit a seizure action plan.
- Training biennially for school nurses on seizure recognition and first aid.
- Training biennially for teachers and school bus drivers on seizure recognition and first aid who have a student with a seizure action plan.

# **Challenges for Students with Seizure Disorder**

- Learning challenges
- Medication side effects
- Missed class time
- Anxiety and stress
- Physical limitations
- Communication challenges
- Lack of awareness



## **Food Allergies**

- 16%-18% of school age children experience food allergy reactions
- 25% of first allergic reactions of children occur at school
- Children with food allergies are more likely to have Asthma
- Over 58,000 school aged children in Louisiana have a food allergy

Highlights of Epinephrine Administration:

- Parent is to provide from their child's healthcare provider prescription
- Parent to provide properly labeled medication
- Parent to sign consent
- School RN is to develop an IHP and an Emergency Action Plan
- Provider to authorize student to self administer and self carry of EpiPen medication
- Allows for school RNs to have Trained Unlicensed School Employees (TUSE) to administer medications
- Allows for schools to maintain a stock supply of Epinephrine
- Liability for school employees



# **Food Allergy Student Challenges**

- Risk for anaphylaxis
- Social isolation
- Diets too low in fat can lead to growth concerns



# **Obesity**

- 35.6% of Louisiana Children age 10-17 are Obese/Overweight
- Louisiana ranks 46 out of 50 in childhood obesity rates
- 1 in 3 children are considered obese in Louisiana



## **Inadequate Dental Health**

- 40% of children have tooth decay by Kindergarten
- 86% of parishes in Louisiana do not have access to oral care
- 56.4% of third grade students had damage to tooth surface/enamel



## **Combating Chronic Absenteeism**

- Recognizing students with chronic health conditions
- Educating teachers and staff
- Work with parents to reassure fears/safety of their child
- Encourage early morning and late afternoon appointments
- Work with educators to offer accommodations to physical activity
- Provide opportunities for make up of missed work
- Utilization of the Diabetes, Seizure, and Asthma Action plans
- Utilization of trained staff in administering medications at school
- Communicate with student's providers for case management



### Reduction of Chronic Absenteeism

Management of chronic health conditions in the school setting by the school RN can help to reduce the number of days a student is absent. Through education of teachers, school staff, administrators, and parents, the student with a chronic health condition can remain safely in school.



### Conclusion


