

Testing Details (including any age requirements / accommodations)	There is no age requirement for taking the exam. Exams must be taken at AAFCS Pre-PAC approved test sites. To become an approved test site, administrators must complete the online Test Site Approval Agreement. Test sites can select their own dates for test administration during the academic year, and upon submitting orders for testing, sites should allow 2-3 business days for order and registration processing and 2-3 days for registration processing. Tests may be administered once the registration is processed and usernames are issued. Testing procedures and assessment information are online. The online exam consists of 80 multiple choice items (70 scored items; 10 non-scored). Assessment is not timed but must be completed in one sitting. The average testing time is approximately 50-60 minutes. The cut score for pre-professional certification is reviewed and updated annually on the AAFCS website. The current scoring list can be found online, and sample test items are included in the Assessment Information Bulletin. Local test administrators/proctors are authorized to make testing accommodations that are formally specified in Individual Education Plans for those with special needs. Industry-Based Certification Requirements: Teachers Bulletin 746, Chapter 5: All Louisiana teachers providing instruction in a course that leads to an IBC must hold the certification that they're teaching students to attain.								
Instructor Certification Requirements (by certifying agency)	AAFCS has approved the request from the Louisiana Department of Education (LDE) allowing state approved special administrations of the <i>Pre-PAC Fashion, Textiles, and Apparel</i> assessment to Louisiana teachers as a basis for satisfying teacher credentialing requirements necessary to award industry-based certifications to students per Bulletin 746, Chapter 5. Restricting the special approval to state-sponsored professional development events is considered to be a viable accommodation, so allowance to permit local/district testing of teachers will NOT be approved and will be considered a violation and breach of the special provision agreement approved by AAFCS. Thus, teachers who need to earn this industry certification through AAFCS must register for and complete the Pre-PAC assessment during the special credentialing administration at state sponsored events.							
Proctoring / Test Security (if any)	Test sites must agree to all security stipulations and proctor requirements as part of the Test Site Approval Agreement. The <u>proctor guidelines</u> are located online. Proctors must be test site employees and school and/or district guidelines should be followed with regard to the proctor selection. Schools may allow teachers to serve as proctors of students they do not teach (for security and liability purposes). If local guidelines allow, the school may allow the teacher on record to proctor but not be the only one in the room (proctor-observer). Proctor instructions for administering and proctoring the Pre-PAC assessments and student instructions for taking the exam are available here . Student instructions are also provided at the beginning of the online exam.

Credentialing Documentation	Individual student assessment/certification results are available to the student immediately upon submission of the assessment. The student will be given an overall test score and will know if the required score was earned. The student will also have access to a break-down of scores by domain/topic area. (Click here to see the current scoring list) A variety of standard reports in the Data Reporting system is immediately available at no additional cost to test sites using login credentials they will be given: a) score list reports b) transcript reports c) assessment overview Membership is not required for certification. The test site coordinator can contact the Pre-PAC office, pre-pac@aafcs.org and provide the student's name if additional information is needed.

Certification Costs / Funding Sources									
Cost Details	There is no cost/fee to become an approved test site. Only approved test sites can purchase and administer exams. The only costs/fees are for the individual assessment products listed below: • \$25 per student for single (one-time) administration • \$40 per student for test/retest administration (provides for initial administration and a follow-up administration/retest by the end of the testing year; this product may be used for pre- and post-testing). See Pre-PAC Academic Pricing Structure for more information about costs.								
Re-test / Refund Policies	Students may retest by two methods: (1) repeat the single test option (\$25 per test request) or (2) initially purchase the test/retest option (\$40) which provides for two administrations of the exam (with no additional cost to retest). The single test option can be purchased and administered an unlimited number of times, but a minimum of 48 hours must elapse before retesting. The additional exam order usually takes 1-2 days to be processed. There are no refunds of exams or testing fees, but any exams purchased by the test site that are unassigned at the end of the testing year (June 30) can be carried forward to the next testing year for assignment and administration.
