Re-Testing (if available)	Re-Testing Procedures	If a student does not achieve a passing score the first time, there is a 24 hour wait period before retaking exam. If a student does not achieve a passing score the 2 nd time, there is a 48 wait time for each subsequent exam retake. There is no maximum number of attempts								
Testing Details (including any age requirements / accommodations)	As noted above, Students must pass three certification tests – one in each domain (Living Online, Key Application and Computing Fundamentals) – to attain the IC3 certification. High School students may take either the IC3 Global Standard (GS) 4 exams or the newest updated version, IC3 Global Standard (GS) 5 exams. Students under the age of 13 must register through their teacher due to consent / privacy concerns. Educators seeking accommodations must email their request to accomodations@certiport.com. Students may attempt certification at any public Certiport Authorized Testing Center. Certiport has Exam Policies in place to protect the integrity of their exams. A school can also become a Certiport Authorized Testing Center (CATC) through an agreement with Certiport.
