POLICY ANNOUNCEMENTS

Placements During LEAP Testing (for schools serving grades 4 and/or 8)

We realize that taking on new students during testing season can be challenging for both the student and the school. While we will continue to place incoming students and approved hardship transfers during Phase 1 and 2 of LEAP testing (in all grades), we do not expect that they will begin attending class until the end of the testing period. Those dates are:

- 3/18 – 3/20: Phase 1 testing and make-up testing
- 4/7 – 4/15: Phase 2 testing and make-up testing

Families will be directed to go to their new school to complete registration during these dates, but to expect to be told that they will not begin classes at their until either Friday, 3/21 or Wednesday, 4/16, whichever is appropriate to their entry date.
