IMPT: Upcoming Preliminary Rosters

Our team is working very hard to finalize rosters as quickly as possible. We anticipate providing preliminary student rosters **by the end of this week**. Once preliminary rosters are ready to share, you will receive a separate communication with detailed instructions for review. It is very important that you keep all roster information confidential until results are declared final. We appreciate everybody's patience as we work to complete the Main Round match. Please prepare for the upcoming roster communication, and the quick review turnaround that follows.

Student Notification

We anticipate student notification going out early next week, which means students with emails will receive email notification as soon as results are declared final, and all students will begin to receive letters in the mail towards the end of next week. Most letters will likely arrive between 4/10 and 4/15. Upon declaring the match final, families will be able to call or visit a Family Resource Center to receive a personalized placement letter, which we will also share with schools. Please let any inquiring families know what to expect for upcoming student notification.

Round 2 applications go to the printers today. Thank you for everybody's assistance in reviewing the materials. This serves as a reminder that Round 2 applications will be available at Family Resource Centers and online only. If families would like to apply in Round 2, please tell them to either apply online or visit our School Choice Advisors. The application launches April 20.

Round Robin Update
