### **Instructions**

# What is considered an "adult learner"?

According to WIOA Title II, eligible individuals are those 1) who have attained 16 years of age, 2) who are not enrolled or required to be enrolled in secondary school under State law; and 3) who are basic skills deficient; do not have a secondary school diploma or its recognized equivalent and have not achieved an equivalent level of education; or are English language learners.

Pursuant to LA RS 17:221 I – 16–17-year-old individuals must be properly exited from a K-12 school setting in order to be enrolled in adult education.

#### Student/Parent/Guardian Information

This information must be completed entirely and brought to the school district where the student is enrolled, or where they reside.

# **LEA/School Response Information**

The superintendent or the designee must complete the applicable information and sign.

- If the individual is enrolled in the school district and the request is denied, a reason must be noted.
- If the student is not enrolled in the school district, but provides documentation (i.e. rental agreement, electricity bill, etc.) that they reside in the district, the school district designee should check the appropriate box.

#### **Homeschool Students**

Per BESE Policy 741: 1103 B.3.b if the local school district denies the request to exit homeschool status to attend adult education, the student may request a waiver from the adult education provider. Students must present documentation from the Louisiana Department of Education that they have been accepted into homeschool status for a minimum of six months.

# **Adult Education Acceptance Information**

Must be completed by the LCTCS WorkReady U Supervisor.

# Ineligibility for Continuance in Adult Education Information

The adult education supervisor is required to notify the exiting school district if a 16–17-year-old student becomes ineligible for adult education services.

**Note:** There are no attendance requirements for homeschool students. Notification to the school district of non-attendance is not required for those students.
