 Criminal background clearance, Child/staff ratio, Supervision, State Central Registry, Prohibited disciplinary actions, Use of passenger restraints, Hazards, Reporting child abuse/neglect, Administering medication to children without authorization or training, CPR/PFA, Insurance, Overcapacity, Falsifying/altering documents, Any validated instance of corporal punishment, physical punishment, cruel, severe, or unusual punishment, physical or sexual abuse and/or neglect if the owner is responsible or if the employee who is responsible remains in the employment of the provider, any activity that otherwise places the health, safety or morals of children at risk, whether on premises, property or vehicle. I understand that non-compliance with the aforementioned serious deficiencies will result in enforcement actions up to and including non-renewal or revocation of my license to operate. sh (provider to initial)
- If the license for this facility is revoked, LDOE shall not accept a subsequent application for this facility or any new facility for a minimum period of two years after the effective date of revocation or non-renewal or a minimum period of two years after all appeal rights have been exhausted, whichever is later (the disqualification period).
