Application Entry Update: Scholarship Schools

We have updated the application training documentation with information on how schools should communicate with parents and data-enter applications now that the scholarship schools are included in OneApp. Please review the attached presentation and ensure that the processes are being followed at your schools. The main takeaways include:

- Common Schools must tell scholarship applicants that they need to submit income eligibility documentation to a Family Resource Center or participating non-public school to be considered for a scholarship award.

OneApp Factsheet
