TEACHER LEADER SUMMIT- RECORDED SESSIONS

The 2020 Teacher Leader Summit: The Virtual Series brought together over 6,000 educators and content experts focused on creating meaningful growth for every student, every day. Educators shared knowledge, learned new skills, and prepared for the 2020-2021 school year.

In an effort to ensure as many Louisiana educators as possible were able to gain the content knowledge

from the sessions, the Department released a [list of sessions](#) that were broadcasted live on YouTube. The live broadcasts allowed educators across the state to attend the sessions live regardless of event registration.

Additionally, all sessions were recorded for offline viewing. The recordings will be posted to the [Teacher Leader Library](#) later this month.

MENTOR TEACHER AND CONTENT LEADER ASSESSMENT SERIES UPDATE REPORT

BESE will receive an update report in June regarding the Mentor Teacher and Content Leader Assessment Series. The update report and recommendations therein were developed based upon feedback from Mentor training participants, approved Mentor training providers, Regional Talent Coaches, and a teacher preparation group that includes representatives from the Louisiana Association of Colleges of Teacher Education (LACTE), private teacher preparation providers, and BESE.

The recommendations in the report include:

1. Reducing the artifact requirements and clarifying assessment rubrics
2. Scaling down (from six to four individual assessments) and restructuring the Elementary assessment series
3. Providing ongoing and increased technical assistance to approved mentor training providers

Given the impact of these recommendations and subsequent policy revision to reduce the number of Elementary assessments, during the Notice of Intent (NOI) period, the LDE will meet with approved providers to share this update report and to continue a dialogue regarding the Mentor Teacher and Content Leader Assessment Series.

TEACHER CERTIFICATION

Practitioner Licenses (PLs) for the 2020-2021 school year and Resident certificates (Rs) for the Fall/Spring 2020-2021 session will begin to be issued on July 1, 2020.

When preparing to submit and submitting applications, please be sure to:

- Update any bookmarks or other documents that refer to the payment portal, as the new payment portal is live
- Download the most current application packet before distributing to students/teacher candidates
- Complete admission date on initial applications
- Complete the GPA met or flexibility form
 - GPA must be the undergraduate GPA and cannot be calculated using the last 60 hours of coursework
- Submit applications as one PDF
- Schedule office hours for specific questions

PRACTITIONER LICENSE TEACHER CERTIFICATION EXTENSION

BESE has granted a regulatory flexibility to extend teachers' practitioner license by one year if they were impacted by ETS' transition to at home tests.
