Louisiana Student Standards and Assessment Update

Louisiana Student Standards and Assessment Update

- Last week, legislative leaders, BESE leaders, and the Department announced an
 agreement that will provide clarity, consistency, and transparency for teachers, students,
 and parents on issues of academic standards and tests.
- BESE will convene professional committees to review and develop Louisiana Student Standards in English and mathematics between July 2015 and February 2016. The process continues the review process BESE has already started and will be conducted through open meetings, ensuring appropriate Legislative oversight.
- If the Legislature or Governor sends the standards back to BESE for further development, our schools continue with current standards while the committees continue their work.
- Under the agreement, the Department of Education would also seek a one-year testing contract for English and math questions, no more than 49 percent of which may be developed through the PARCC process. In 2016, upon adoption of revised standards, the Department will seek a long-term testing contract in English and math.

2015-16 Academic Support: Standards Review Committee

Data Closeout

Act 837

Act 837 provides for limitations and prohibitions on the collection and sharing of student information.

The Department provided guidance around four main areas of impact of the law:

- Unique student identifier system
- Parental consent
- Contracts and data sharing agreements
- Adapting statewide processes that rely on students' personally identifiable information

To implement the requirements in Act 837, LEAs should:

- Ensure all students enrolled in public elementary and secondary schools receive unique student identifiers by June 1
- Ensure students in grades 8-12, especially seniors, have parental consent to determine TOPS eligibility and postsecondary admission
- Opt into data sharing agreements for services that are currently provided under LDE contracts
- Modify their local student information systems based on LDE guidance

15-16 Academic Support: Believe and Prepare Update

In April, the Department hosted forums in four locations across the state to discuss policy options and hear feedback on implementation.

Generally, the feedback from school systems and preparation programs showed agreement around:

- The need for **stronger partnerships** and how the Department should support the process of partnership development to better meet staffing needs
- The need for **longer practice experiences** that provide candidates with a full range of experiences of a practicing teacher (the start of school to the close of school)
- The value of using multiple sources of information about program graduates' success with students in order to support preparation programs' improvement

School system leaders and preparation program faculty shared detailed implementation considerations on all of the proposed policy shifts that will guide policy development.

15-16 Academic Support: Believe and Prepare June Forum

The Department will host a **policy forum on June 23 in Baton Rouge** to continue its discussion of policy shifts that would grow Believe and Prepare pilots' most promising practices.

Course Choice/SCA 2015-16

Course Choice offers students opportunities to pursue college coursework, Advanced Placement courses, and career training that prepare them for opportunities after high school.

- <u>Course Choice/SCA registration</u> for the 2015-16 academic year is scheduled to open in mid-May. A tentative catalog can be found <u>HERE</u>.
- Per Act 837 (Data Privacy) LEAs must have parental consent for students to enroll in voluntary/3rd party programs such as Course Choice/SCA providers. This will go into effect on June 1, 2015.

eGMS 2015-2016 Application Rollout

- The 2015-2016 allocations approved at March or April BESE are active in the 2015-2016 eGMS application for budgeting.

- Preliminary allocations for FY15 Federal Grants will be loaded on a rolling basis as formula calculations are approved and validated.

Title I Schoolwide Fiscal Flexibility

- Title I school wide fiscal flexibility gives Title I schools the ability to fund any
 educational activity in their school budget to upgrade their overall educational
 program with no fiscal supplanting concerns. This allows principals the ability to stay
 focused on instruction rather than federal program fiscal requirements.

High Cost Services

- High cost services are available to districts for students who qualify for services under the Individuals with Disabilities Education Act (IDEA) with a total cost of educational services that is three times the average state per pupil expenditure.
- First time funded through MFP and IDEA Set Aside
- MFP funds must be expended by 6/30/2015
- Districts can submit claims from 7/1/2014 -10/15/2014 against MFP funds
- Federal funds through IDEA Set Aside must be claimed by 9/30/2015
- IDEA funds cannot cover claims from 7/1/2014 10/15/2014

District Action Step: Districts need to submit claims for reimbursement before 6/30/2015 to fully expend SGF-MFP dollars.
