Narrative Explanation of Expenditure Impact

1) Implementation Costs:

Current law (R.S. 17:351.1) provides for a local review process for curriculum and other instructional materials not reviewed by the Louisiana Department of Education (LDOE). SB 52 further requires that local education agencies (LEAs) add to their local policies and implement evaluation criteria and procedures by which review committees shall determine the extent to which textbooks and other instructional materials submitted for review align with state content standards. There could be indeterminable increased costs associated with conducting such evaluations and procedures, particularly if LEAs engage external experts and consultants, enter into contracts, and/or pay for travel, meeting room space, meals, etc., for review committee members and their meetings. This provision adds no cost to the implementation of this law at the state level.

The law further requires that the materials reviewed and deemed by the LEAs to align with state content standards be given equal weight by the LDOE in all matters including determination of eligibility for state or federal funding based on the LEA review. Even with this change in state law, LDOE must comply with other federal and state requirements on the use of federal and state funds for curriculum and instructional materials.
