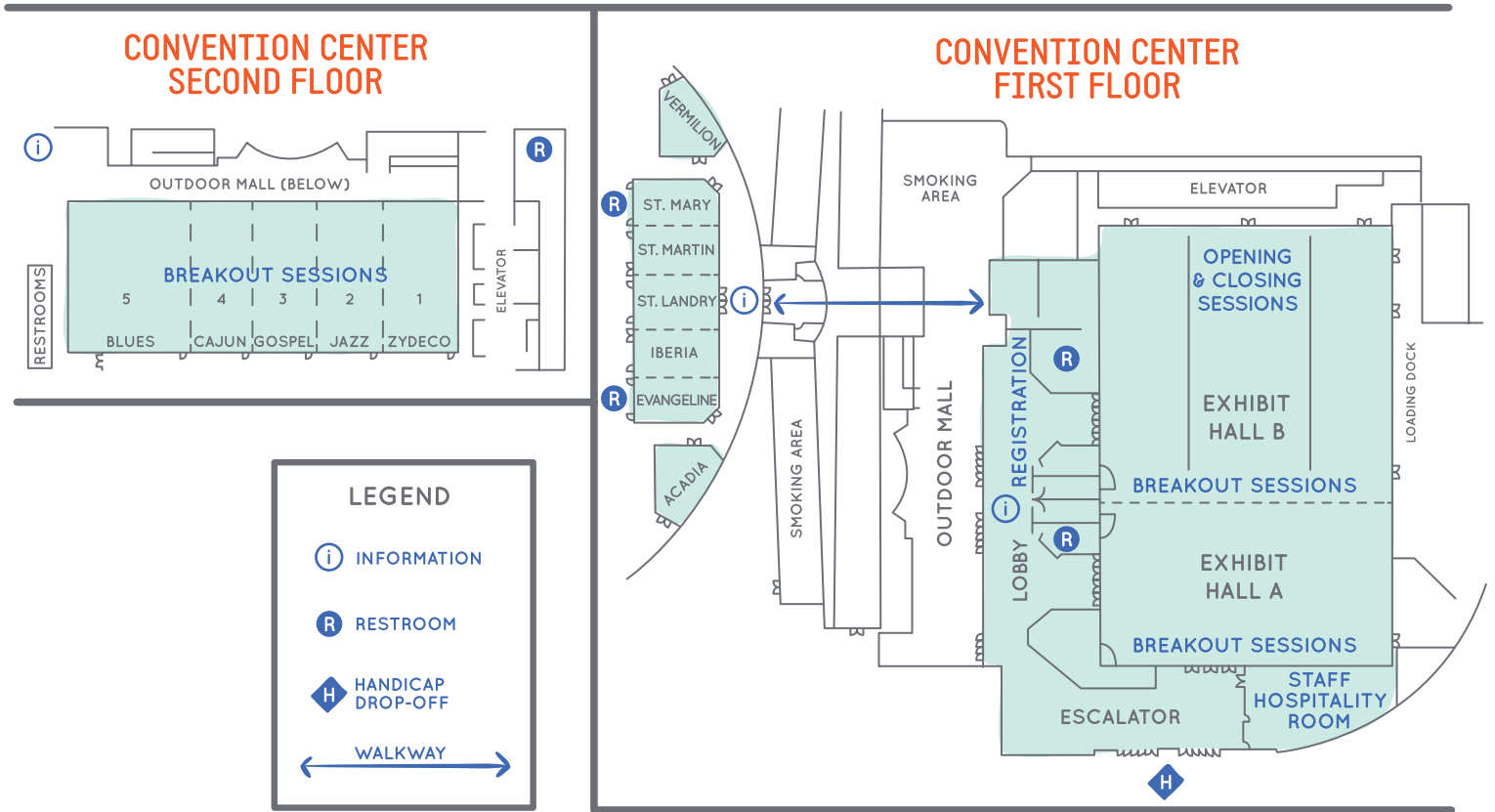


# COLLABORATION SITE MAP
