# **Guest Message: Nonpublic School Choice Team**

Nonpublic School Choice programs - including the Louisiana Scholarship Program, Tuition Donation Rebate Program, and the School Choice Program for Certain Students with Exceptionalities - play a critical role in the Department's strategy to ensure that all Louisiana students have access to the educational opportunity that will best prepare them for college and career success. Almost half of all Louisiana nonpublic schools participate in one or more of these school choice programs. While students can ultimately only participate in one school choice program (but may apply to all three) - nothing prevents a nonpublic school from participating in all three programs. In fact, 73% of all choice program participating schools participate in at least 2 out of the 3 programs.

Previously, the Department has used multiple, different communication structures for each separate program. However, as multiple schools participate in multiple school choice programs, the Department recognizes the increased burden of tracking communication and action items across different programs.

In order to streamline communication so all schools clearly and concisely receive holistic, centralized information about nonpublic school choice programs, the Department is replacing the Scholarship newsletter with a

nonpublic schools with important information for all choice programs and continue to deliver helpful school resources and supports from the Department.

In addition, the Nonpublic School Choice Newsletter will seek to include content personalized specifically for nonpublic schools. As part of this strategy, the Department wants to include a special "Shout Out" section to recognize the important work of nonpublic schools and individuals serving Louisiana's children. ### **Action Items**

#### **Quarter 3 (Q3) Enrollment Count**

The Q3 enrollment count began Wednesday, February 3 and will end **Friday, February 5**. Please note that the count must be completed prior to the deadline. Due to the Mardi Gras holiday, schools will be unable to complete the count the following week.

Schools are required to confirm Scholarship student enrollment for the Q3 payment in SEE. Each participating school must review their Scholarship roster and report which students were enrolled and have demonstrated a pattern of attendance as of the count date. All schools must complete the enrollment report by midnight, **February 5** in order to receive their Q3 payment for those enrolled students.

#### **Accessing Assessment History**

In prior years, schools had the ability to download and search student test history via LEAPWeb. Beginning in early February, this functionality will shift to LEADS and schools will have the ability to download and search assessment history through the portal. Both extracts and reports will be available for LEAP, iLEAP, EOC\*, PARCC, LAA1, LAA2, and ELDA assessments. Full details were provided in the February DTC Webinar.

- New Accessibility and Accommodation Manual: The Grades 3-8 Accessibility and Accommodation Manual will be
  available by the end of the week within eDIRECT. The Accessibility and Accommodation Manual provides guidance to
  districts and decision-making teams to ensure that assessments provide valid results for all participating students. It also
  offers test administration guidance for before, during, and after testing.

#### **Test Administration:**

- LAA1/ELDAAssessments: LAA1 and ELDA assessment administration began yesterday, February 1, and continues through March 11.
- ACT Assessment: Starting yesterday, February 1, 2016, district or school test coordinators should submit online orders for non-college reportable accommodation materials for the ACT. The deadline to submit these orders is February 11, 2016. ACT non-secure materials will be delivered to LEAs or districts by February 4 for distribution to schools.
- **LEAP Assessments:**School test coordinators should begin delivering <u>test security and administration training</u> to test administrators or school personnel for applicable assessments.

#### **Technology Readiness:**

- Preparation for Online Practice Tests: The online practice tests will be available in the INSIGHT assessment platform
  by the second week of February. In order for students to access these tests, LEAs will need to upload student rosters into
  the <u>Practice eDIRECT</u> prior to the assessment. Directions for upload can be found within the user guide within the
  documents section of the Practice eDirect site.
- Technology Readiness Tool (TRT): Districts should access their <u>Technology Readiness Tool</u> reports within the TRT online survey system to support them in making informed decisions regarding online testing. A guide highlighting the key reports is posted on the TRT homepage. Once district technology staff have reviewed these reports, they should begin installing their Testing Site Manager (TSM) servers and performing an initial test of their devices and networks with the tools provided in the online <u>Practice eDirect</u> site.
- Online vs. Paper Assessment Survey: This spring, students in grades 3 through 8 may test online. The <u>survey</u> allows districts to indicate whether they will administer tests to grades 3 through 8 online or on paper. It will also allow districts to sign up to participate in the social studies field test. District responses are due <u>by late February</u>.\*

\*Note: LEAs will determine testing formats and may chose options by entire LEA, schools, or grade levels.
