# **Message from the Deputy Superintendent**

Dear Colleagues,

There is a quote that's resonated with me since my time in the classroom.

"By failing to prepare, you are preparing to fail." — Benjamin Franklin

This simple truth speaks to the intentionality every professional must bring to their work. It's especially relevant to us as educators. As we near the halfway point of the school year, the goals you set this summer are still within reach. Achieving them requires deliberate and focused preparation.

As you plan for November, keep the following in mind:

- **Lesson preparation is essential.** It remains one of the most effective ways to strengthen curriculum implementation and deliver effective instruction.
- **New tools are available.** We recently released <u>updated resources</u> during our fall School Support Institutes to support unit study and lesson preparation in literacy and math. These tools are also well-suited for teacher collaboration.
- Leverage teacher collaboration. There is real power in examining student work and planning upcoming instruction together, especially when using HQIM to meet the needs of all learners.
- Stay aligned with the <u>Louisiana Educator Rubric</u>. Lesson preparation connects directly to the Planning Domain, which emphasizes high-quality curriculum, standards alignment, and purposeful instruction.

These practices help set the foundation for effective teaching and learning. Your intentional planning makes a difference for every student.

- Strategic plans for the disposition and security of school buildings and property, including specific timelines for securing campuses and disposing of property

# 2025-2026 High School Coaches CPR, First Aid, and AED Certification Survey

Please share with high school principals.

Act 95 of the 2024 Regular Legislative Session states that beginning in the 2025-2026 school year, any high school employee serving as a coach for the school shall obtain and maintain certification in cardiopulmonary resuscitation (CPR), first aid, and the use of automatic external defibrillators (AEDs). The certification shall be consistent with the guidelines of the American Heart Association, American Red Cross, or other nationally recognized, evidence-based emergency cardiovascular care organizations.

Funding is available to assist school systems and schools in complying with the statute. Please have the principal or athletic director complete the <u>survey</u> by or before November 21.
