SURVEY: ALIGNING PROGRAMS TO UPDATED PROGRAM DESIGN POLICIES

On October 5, 2017, the Department sent a link to a survey to all teacher preparation programs to gather information regarding each program's plans for aligning programs to updated program design policies. This information will help the Department ensure appropriate staffing to review applications and inform BESE, as needed or requested.

FORMULA FUNDING

Mentor and Resident Stipends

Approved by BESE in October 2016, the Teacher Preparation Transition Support Program supports the design and implementation of competency-based teacher preparation programs that include at minimum a full-year residency. The program includes three years of formula-based funding. School districts receive funding to pay stipends to undergraduate teacher candidates serving in yearlong residencies and their mentor teachers.

- \$2,000 stipend for undergraduate teacher residents
- \$1,000 stipend for mentor teachers hosting undergraduate teacher residents

In August 2017, the Department requested yearlong residency placement information from universities and their partner school districts for the 2017-2018 academic year. Stipend allocations for 2017-2018 will be calculated based on the residency start and end date and mentor assignments. BESE will consider these allocations on October 17, 2017. There are three funding sources for these allocations: Title I 1003(a), IDEA, and 8(g). Title I 1003(a) funds were allocated if the residency is taking place in a school with 50 percent or greater economically disadvantaged students. IDEA funds were allocated at a 100 percent rate if the resident is pursuing special education certification and at a 50 percent rate if the resident is working in a classroom that provides an opportunity for direct practice/training working with students with disabilities.

HIGH-COST NEEDS FUNDING

On October 17, 2017, BESE will consider high-cost needs funding for 2017-2018. Any BESE-approved preparation provider was eligible for supplemental funding of up to \$20,000 to support the following activities:

Accelerated design, approval, and/or launch of aligned programs; **Essential, unique, high-cost needs** that must be met in order to successfully transition programs and obtain BESE approval.

After a competitive grant application process, the following preparation providers are being recommended for a high-cost needs allocation: Centenary College, Grambling, Louisiana Tech, Loyola, LRCE, LSU-Alexandria, LSU-Baton Rouge, LSU-Shreveport, Northwestern, Southeastern, St. Bernard Parish, Teach Ascension Academy, TNTP, Tulane, University of Louisiana at Monroe. US PREP SUPPORT

US PREP will provide individualized support to providers focused on the shift to yearlong residencies and competency-based design. This support is optional and delivered at varying levels based on provider needs and available budget. The support from US PREP will begin with a needs assessment. This assessment is available, but optional, for those preparation providers who are not utilizing support from US PREP. The needs assessment will be sent to all preparation providers on **October 16, 2017.**
