Act 144: K-8 Career Awareness and Exploration

[ACT 144 \(2026\)](#) requires that each school year, at least six activities shall be conducted at each grade level in grades six through eight. The activities must align with the high-demand sectors by region and state as provided annually by Louisiana Works.

- Each school year, at least three of the six activities for each grade level shall meet one of the following criteria:
 - An activity that provides direct interaction with an employer.
 - An activity that involves career pathway instruction linked to high school course options.
 - An activity that provides a work-based learning exposure.
 - A career interest inventory.
- At least one career awareness and exploration activity shall be documented for each school year in each student's Individual Graduation Plan (IGP), and career interest inventories should be completed in grade six and updated in seventh and eighth grades.

Act 144: Individual Graduation Plans (IGP)

The [Individual Graduation Plan](#) (IGP) document has been updated to reflect the requirements of [ACT 144](#). The plan now has sections added for middle school career activities as well as career interest inventories.

Guidance is in the process of being developed on the additional documentation that is required for career activities and interest inventories stemming from ACT 144.

Act 413 (SB 482) and CDF Reporting

Annual LDOE Publication: As mandated by SB 482 (Act 413 of 2026 Regular Session), the Louisiana Department of Education (LDOE) must annually publish a list of Local Education Agencies (LEAs) that have either:

- Failed to spend at least 95% of their Career Development Fund (CDF) allocations.
- Failed to report their expenditures.

Publication Schedule: The annual report is published every December and reflects allocations from the previous year.

Reporting Deadline: The 2025–2026 CDF Final Report remains open for school districts to submit reporting until August 31, 2026.

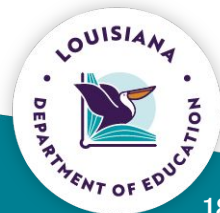

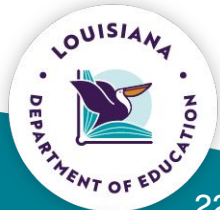


Digital Device Guidelines

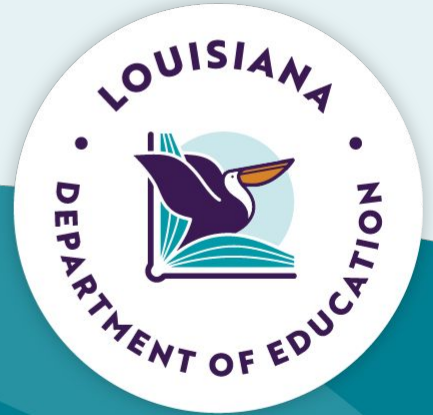
Human Trafficking Prevention

Under [Act 737](#) (2026), each school must designate at least one counselor, mental health professional, or administrator to complete annual advanced training on human trafficking.

Leaders must adopt the required policy, designate the appropriate employee, and document compliance.

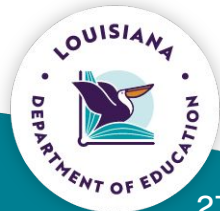
