The 2025-2026 FAFSA is open. The 2025-2026 FAFSA form is for students attending college in the fall of 2025, including 2025 high school graduates. Students are encouraged to create their FSA ID before beginning their FAFSA application. Starting with graduates of the 2024-2025 school year, FAFSA is not a graduation requirement, but school systems are still obligated to assist those students who desire to complete the application.

Online Training for CTE Issuing Officers Now Open Please share with administrators, counselors, and teachers.

To issue Career and Technical Education (CTE) employment certificates, individuals must be officially authorized as CTE Issuing Officers by the Louisiana Workforce Commission (LWC). Authorization necessitates successful completion of an online LWC training course and receipt of a completion certificate. Requests for authorization should be submitted by principals or superintendents on official school/system letterhead. The request must include the names, titles, and email addresses of the prospective issuing officers and should be sent to laborprograms@lwc.la.gov.

Cohort Graduation Data Certification

Please share with administrators, counselors, and testing coordinators.

LA Data Review opened in April for accountability contacts to retrieve the 2024 cohort graduation rosters. This information should be distributed to schools, and requests for changes to data that will be used for the calculation of graduation rates and related graduation indices used in the 2024 SPS.

The LDOE will continue to conduct exit code reviews for students.

Elimination of Cohort Graduation Lag Year

Please share with administrators, counselors, and testing coordinators.

The 2024 SPS will include data from both the 2024 and 2025 cohorts to eliminate the lag year for reporting graduation data.

Beginning with the 2025 graduation cohort, data certification will be divided into two phases. The first phase will continue being conducted during the spring and will include exit code audits only for



students who have exited as transferring out of state, to approved nonpublic schools, and to BESE-approved home study. The second phase will be conducted during the summer and will include reviews of LEA and site flags, AP, IB, CLEP data, and HiSET attainment.

Requests to update IBCs and DE course codes are no longer reviewed or approved.

Q & A With COunselor COnnect!

Q: What is Work-Based Learning?

A: <u>Work-Based Learning</u> connects high school students with real-world work experiences while helping businesses develop their talent pipeline. Students earn school credit while gaining meaningful exposure to industry while receiving financial compensation.

• Internships are paid, short-term, project-based work during the school year or summer. Internships include 106.2 hours of work with an employer and 26.55 hours of classroom instruction. Work Based

Learning

- Cooperative Education is paid, credit-bearing employment aligned to a student's career goal. Cooperative education involves 15 hours of work and 5 hours of classroom time each week
- **Registered Apprenticeships** are on the job training and work-based activities where students work with an employer directly aligned to their pathways to gain real-world hands-on experience to strengthen skills learned during classroom instruction.
