#### **FAFSA Policy and Assistance**

As a reminder, at its March 2024 meeting, BESE approved updates to the Notice of Intent regarding Bulletin 741 Louisiana Handbook for School Administrators - §901 and §2347, focusing on policy surrounding FAFSA for 2024-2025 cohort graduates.

- LEAs must ensure that each student receives adequate support in completing and submitting an application for financial aid.
- An updated parent and student financial aid planning toolkit will be made available to school systems.

### 2024 - 2025 CDF Updates

During the Jump Start Convention, the LDOE presented potential changes to the CDF list to garner feedback from school systems. In conjunction, the LDOE also conducted a fiscal impact analysis on potential changes which include an analysis of CDF funds school systems are carrying over.

Because of the need for continued, in-depth analysis and consideration of system feedback, the CDF list will not be modified for the 2024-2025 school year. However, in the fall of 2024, the LDOE intends to publish an updated CDF list that will be implemented in the 2025-2026 school year along with a formal process for school systems to request courses be added to the list.

### **Graduation Date Removal Codes**

Please share with school administrators and senior counselors.

Graduation dates may be removed from a student STS transcript due to the following reasons:

Code	Problem	Solution
2	23 credits	Not having 23 credits Student does not have at least 23 credits. Check transcripts and course part numbers.
3	Core Progress	Core Progress not met Student is missing at least 1 category in his/her diploma path. Run student diploma calculation and see which category is not met.
4	Pass GEE/EOC	GEE/EOC flag Student does not have a Y in the GEE/EOC flag field.
5	CDV	Career Option code not CDV for path CD Student on CD diploma pathway requires a CDV in career option code drop down.
6	IBC	No IBC for path CA CA student does not have an IBC loaded correctly into eScholar and therefore is missing the required IBC in STS.

### From the LOSFA Counselor Communication

Please share with administrators and school counselors.

LOSFA will begin processing the graduating class of 2024 in June! Here are a few reminders to make sure the processing season runs as smoothly as possible:

#### Student Transcript System (STS) Reminders:

- The graduation date must be set.
- Parental Consent is set to "Yes" (both public and private schools).

For public high schools, a signed LOSFA Consent Form must be on file at the school or district with permission granted for the release of STS records to LOSFA before the Parental Consent is set to "Yes" in STS.

- Students are not listed on the No PII in BLE Report (public schools).
   How to Pull a PII Report:
  - School districts will no longer receive notices from the LOSFA Audit Department
  - Select a school
  - Print & Export tab
  - Select Printing/Exporting Transcript Records
  - Select No PII found for students in BLE (XLS)
  - o If a student is missing a SSN, name, or birthday in eScholar, they will appear on this report. LOSFA and BOR must have these 3 pieces of information to link records for college enrollment and TOPS scholarships. If the student has a check mark, then that piece of information is ok. If the student has a question mark, it means that piece of information is missing in eScholar. NOTE: To make a change to PII, please put the change in eScholar, wait at least an hour, and then update the information in STS.
- All transcript information must be received via STS. LOSFA will not accept faxed or emailed high school transcripts.
- The recommended deadline to have transcript information entered is June 15.

#### **ACT Reminder:**

- LOSFA now receives ACT WorkKeys directly from ACT. Scores no longer need to be sent to LOSFA, except for qualifying scores earned by graduating seniors after April 30th. Please use LOSFA's WorkKeys Test Result Form to submit scores. The completed form can be emailed to SGIE@la.gov.
- LOSFA does not use super scores.
- LOSFA cannot accept faxed or emailed ACT scores.

#### **Documentation LOSFA may need to process students:**

- Residency documentation
  - School districts will no longer receive notices from the LOSFA Audit Department to verify students' residency.
  - Students who list a parent as an out-of-state resident on the FAFSA will automatically receive a <u>Residency Affidavit</u> to complete.
- Home Study documentation If a student attended your school and left to complete high school
  as a home study student, LOSFA needs a letter on school or district letterhead stating that the
  student left your school in good standing at the time the student enrolled in a home study
  program.
- Please encourage your students to set up a Student Hub account. This is the quickest and easiest way for students to check their TOPS eligibility.
- The TOPS status of 2024 graduates for each high school will be available once processing begins in June. The report can be accessed under <u>TOPS Status Statistics</u>.
