Grants of up to \$40,000 per school system are available. Applications will be accepted via eGMS within the competitive funding tab for 2025-2026.

#### **Upcoming Launch of Kindergarten Dyslexia Screening Platform**

The LDOE is excited to announce that the dyslexia screening platform for Act 266 Kindergarten Dyslexia Screening will open soon. This year, district test coordinators will play a key role in assisting with the testing process, utilizing the Review 360 platform to administer the Shaywitz DyslexiaScreen.

The screening process will occur around the same time as the end-of-year DIBELS screener. Stay tuned for additional training opportunities and guidance from LDOE to ensure a smooth and effective implementation.

Administering the End-of-Year DIBELS Screener for Students with Limited Verbal Skills Please share with assistive technology coordinators, general education teachers, special education leaders, special education teachers, and speech-language pathologists.

The LDOE recognizes the importance of accessible assessment opportunities for all students, including diverse learners with limited verbal skills. As part of the End-of-Year DIBELS screening process, these students should

complete the assessment using their appropriate mode of communication, including Augmentative and Alternative Communication (AAC) when necessary.

Students with limited verbal skills, as documented in their Individualized Education Program (IEP), will complete the screener using the paper version of DIBELS 8. They should also be provided with extended time to complete the DIBELS® 8 probe, as appropriate.

AAC Options for DIBELS Administration: Students may respond using a variety of unaided or aided communication methods, including:

- Unaided AAC: Gestures, facial expressions, American Sign Language (ASL), finger spelling, or Visual Phonics hand cues
- Aided AAC: Communication boards with symbols or text, picture-based systems, printed words, or electronic devices that generate speech

For students completing the Letter Naming Fluency subtest, the test administrator may point to each letter while the student responds using assistive technology, ASL, finger spelling, and/or a speech-generating device.

#### **Alternate Assessment Participation Review**

Under the Every Student Succeeds Act (ESSA), any school system with more than 1.0 percent of students participating in the ELA, math, or science alternate assessment must take certain actions.

#### **LEAP 2025 Grade 12 Spring Retesting**

Please share with school leaders and testing coordinators.

This year, dedicated senior forms should be assigned to grade 12 students for Algebra I, Geometry, and Biology. Assigning the senior form, which can only be assigned to students identified as grade 12 in DRC INSIGHT, assures a quicker return of the high school results. Students assigned the senior form must all be placed in a special test session to select the form. Please do not identify any students as grade 12 unless it can be confirmed in the official enrollment record in EdLink 360.

- The forms for English I, English II, U.S. History, and Civics are the same for grade 12 students as for students in other grades
- Students identified as grade 12 in DRC INSIGHT will continue to receive an automatic rescore regardless of the form that they take
