## **Message from the Superintendent**

Dear Colleagues,

Louisiana K-3 students showed encouraging gains on the literacy screener administered at the start of this school year. Reading proficiency is up when compared to last year's beginning of year screener and when looking at how students fared as they advanced from one grade to the next.

You can find our <u>release</u>, the <u>2024 Fall Reading Report</u>, and <u>school system data</u> online. Here are some of the highlights.

- The overall K-3 proficiency rate is up 2.3 percentage points.
- First grade improved by 4 points, second grade by 3.8, and third grade by 2.4.
- Student cohort data increased by 9.3 percentage points, with last year's kindergarteners leading the way.
- Last year's kindergarteners improved by over 20 points this year as first graders, last year's first graders improved by 8.6 points as second graders, and last year's second graders improved by 3.3 points as third graders.

Louisiana students are benefitting from quality instruction, sound policy, and a return to basic fundamentals like phonics. We're seeing encouraging growth and must take advantage of this opportunity to continue aligning our state around what we know is best for students and teachers.

With Christmas and New Year's coming up the next two weeks, this will be the final newsletter until January 7, 2025. On behalf of everyone at the Louisiana Department of Education, I'd like to wish you and your family a merry Christmas and happy New Year.

The Louisiana Board of Elementary and Secondary Education (BESE) approved the review process during the December meeting, and the standards review committee application is now open. Louisiana teachers, administrators, school system staff, higher education faculty, parents, and community members are encouraged to apply. Participation requires attendance at regular in-person meetings scheduled from April through July. Funding is available for participants traveling long distances.

#### **LDOE Removes \$25 Credential Clearance Processing Fee for Certification**

The LDOE previously announced a \$25 processing and handling fee for the Credential Clearance (CC) application, applicable to certification applicants without a criminal background check (CBC) on file and run in the past five years.

Applicants will not be required to pay a fee to the LDOE when submitting their Credential Clearance (CC) application packet. All other certification fees will remain the same as outlined on the <u>Certification Fee chart</u>. The previously communicated fees associated with the criminal background check for the vendor, state police, etc., also remain the same.

#### **LEAP 2025 Fall High School Testing**

## **Eligibility for Participation in LEAP Connect or ELPT Connect**

Students must meet eligibility criteria to participate in any alternate assessment. The final determination must be made no later than January 10 as evidenced by the IEP in eSER. Students who participate in alternate assessments and who are not deemed eligible by the deadline will receive an achievement level assignment of unsatisfactory for each subject in school and district performance score calculations.
