### **LEAP Connect/ELPT/ELPT Connect**

The administration window for LEAP Connect, ELPT and ELPT Connect will close at the end of day on Friday, March 27. Please see important dates below.

- March 27: Apply non-participation codes for students who did not participate in testing and for whom there is documentation to support the code

## **Cameras in Testing Rooms**

**Please share with testing coordinators, school staff, and system leaders.**

Please review the updated camera policy regarding cameras in testing rooms.

1. ACT strictly forbids the use of cameras in classrooms while administering ACT. Cameras should be turned off.
2. For LEAP, LEAP Connect, ELPT/ELPT Connect and K-3 screening,
  - a. In order to ensure compliance with department agreements to maintain the industry standard security on test items, no recording of items, derivatives of items, readings of items is permissible.
  - b. Any camera which records or broadcasts in any way which remains on during testing must be positioned in such a manner so that it is facing students such that any screen being used for the testing is not visible to the camera. If a student requires a test to be read aloud, the audio feature of the camera recording shall be turned off. As an alternative to turning off the audio feature of the camera, if a student requires a test to be read aloud, headphones with audio not accessible to the camera recording audio feature may be used or the student may be moved to an alternate location where audio recording does not occur.
  - c. Any video or audio recording of all or any part of any secure test item is a violation of the test security regulations in BESE Bulletin 118. A violation of the testing procedure will result in a void of the test results.
  - d. BESE and LDOE take violations of the regulations governing test security seriously. Any member of a local school district's staff who violates regulations governing test security may receive certification sanctions as set forth in BESE Bulletins 118 and 746, up to and including revocation of a staff member's certificate.
  - e. Disabling the audio recording for K-3 screening and ELPT/ELPT Connect applies only to external recording, and does not apply to audio recording required in the testing platform.
