Dear Believe and Prepare Community,

Louisiana's <u>English Learner (EL) Framework</u> provides a clear structure for how schools and preparation programs can work together to ensure every teacher is ready to support English Learners in their classrooms. Organized around five focus areas — Leadership and Program Development, Rigorous Instruction and Collaborative Planning, Data-Informed Decisions, Planning for Future Success, and Family Support Systems — the Framework highlights the shared responsibility of developing instruction that promotes both language growth and academic success.

For preparation providers, the Framework serves as a tool for aligning coursework and field experiences with the instructional practices that most benefit English Learners. It encourages teacher candidates to understand how language development connects to content learning and how to plan lessons that include meaningful language supports. When new teachers learn to use scaffolds, model vocabulary, and create structured opportunities for discussion and writing, they are better equipped to make rigorous content accessible for all students.

The Framework also emphasizes collaboration and data use as essential components of strong instruction. When preparation programs model these practices, teacher candidates enter the classroom ready to plan with colleagues, analyze student progress, and adapt instruction to meet learners' needs.

By connecting teacher preparation to the Louisiana EL Framework, preparation providers play a vital role in building a workforce of educators who are confident, knowledgeable, and prepared to help every English Learner thrive.

### **Geaux Teach Scholarship Program**

Act 463 of the 2022 Regular Session of the Louisiana Legislature established the Geaux Teach Program, which provides scholarships to students enrolled in teacher preparation programs at the state's postsecondary institutions approved by the Board of Elementary and Secondary Education (BESE). Funding is also available to students attending certified alternative teacher preparation programs approved by BESE.

Students may receive up to \$5,000 annually to cover tuition, fees, textbooks, and other instructional materials required for enrollment. Billing dates for the fall semester/term are **November 1**; for the spring semester/term, May 1; and for the summer semester/term, **July 1**, when applicable.

## **Teacher Preparation Quality Rating Performance Profiles**

Teacher Preparation Performance Profiles are ready for review. Deans and directors will receive an email with information regarding profile release and meeting options for this year.

2023-2024 TPQRS Performance Profiles will be released in November, and LDOE will email instructions on how to access the Performance Profiles and schedule debriefing meetings. Providers who have effective ratings or higher in both pathways will not require a debrief session. Debrief sessions are tailored to each provider and will provide insight into 2023-2024 Quality Rating Scores, as well as support programs that score Needs Improvement in one or more pathways. The TPQRS Performance Profiles will be released publicly to the Louisiana Believes Preparation Library in January 2026.

### **Spring 2026 Program Approval Cycle**

The <u>new program application window</u> opened on **September 1** for the spring cycle for teacher preparation programs, mentor teacher, content leader, and early childhood ancillary certificates. All applications are due by **December 10**. A notice of intent must have been received by **October 1**, for an application to be considered for program approval.

### **Program Approval Reminders**

When considering a change to a program, email <u>believeandprepare@la.gov</u>. The preparation team will meet to determine whether the change is minor or major. If the change is minor, the change must be noted on the letterhead and signed by the dean. If the change is major, the provider must undergo the program approval process to obtain approval for the change. This process is crucial for candidates to obtain certification upon completing their coursework.

### **Louisiana Educator Certification Portal (LEC)**

These resources include user guides and video recordings designed to assist with navigating the LEC platform. Materials are available for each user role, including: applicants, public and non-public schools, preparation providers, and early childhood centers.

**Praxis Free After Three** 

Beginning October 1, 2025, Praxis offers free retakes for test takers who have completed three attempts on the same Praxis test. Please see the <u>frequently asked questions</u> one-pager for additional information.

#### Status of Fingerprinting and Clear Credential

Applicants have multiple options to check the status of fingerprinting.

- The applicant can check fingerprinting status on IdentoGO's website: <u>IdentoGo Status Check</u>.
- All stakeholders can check <u>TeachLouisiana.net</u> to verify the certification record, which will show the "Clear Credential" if fingerprinting has been completed under our service code.
- When clicking "Add New Application" in the <u>Louisiana Certification System (LEC)</u> system, if the applicant is provided a full menu of application types, then the applicant is cleared; an employer or program provider will be able to send a cleared applicant any application, not just the "Fingerprint Clearance" application.

If an applicant is not cleared with the "Clear Credential" in three weeks or less following fingerprinting under service code **27N5HQ**, email <u>EducatorClearance@la.gov</u> or submit a question through the <u>Teacher</u> <u>Certification Help Portal</u> using the topic "Background and Professional Conduct".
