#### DEAR PARENT/GUARDIAN:

Our records indicate that your child, Lesie Mauthe has 10.0 UNEXCUSED ABSENCES/TARDIES. As per district policy, this information has been forwarded to the District Attorney's Office (trucy center). If this continues, you and your child will be in violation of Louisiana Truancy Law R.S. 17:233.

Attached is a detailed list of days missed along with a school attendance policy statement. Note that the detailed list indicates whether you have or have not provided documentation to the school office for consideration in absence calculations.

Please note that total UNEXCUSED ABSENCES/TARDIES are 8 PER SEMESTER for grades 9 - 12, and 16 PER SCHOOL YEAR for all other grades. This distinction is due to Carnegie Unit accumulation for High School graduation.

#### BIENVILLE PARISH TRUANCY ASSESSMENT AND SERVICE CENTER

Levels of Intervention 2024-2025 School Year

I. 3 Unexcused Absences

- Referred to the truancy center by the school School faxes information regarding absences to the District Attorney's Office (truancy center) and copies the school board.
- B. The truancy center begins a file for the child.
- C. A letter is sent home from the District Attorney's Office-truancy division
- II. 5 Unexcused Absences

A. The school faxes the second referral to the District Attorney's Office (truancy center).
B. A DA subpoena is issued for a meeting with Tammy Jump.
C. The truancy center will monitor the child each weak


- III. 7-9 Unexcused Absences
  - A. A hearing is scheduled in front of the district judge with the child, parent and truancy officer present. A DA subpoena is issued for the child and the parent to appear in court.
  - B. The child is placed under court order to go to school and given certain consequences for further truncy to be determined by the truncy officer and the judge. The parent is also placed under court order to have the child in school.
  - C. The truancy center again "flags" the child at school. The truancy center will monitor the child each day.

#### IV. Additional Unexcused Absence

- A. If the student continues to be absent, the truancy center obtains a warrant for the parent for improper supervision.
- B. The parent is arrested and is prosecuted in criminal court.

The Saline High Recovery Program allows students to make up hours for unexcused absences from the fall semester that exceed the allowable limit. To be promoted or graduate, students must complete these makeup hours during the Spring 2025 semester.

If a student is offered Attendance Recovery and chooses not to participate, they won't be able to appeal their attendance at the end of the year. They will receive no credit for courses where attendance requirements were not met.

Students are expected to attend the scheduled recovery dates and times until they have fulfilled the required number of hours for recovery. Recovery sessions will not be rescheduled unless Ms. Mauthe has an emergency or the student has a significant emergency, such as a family death or hospital stay.

Please bring missing work, homework, or a book to read. Those who show up without something to do will be assigned Test Prep activities on IXL or Edgenuity.
