



Background

On February, 2019, the Board of Elementary and Secondary Education (BESE) updated policy* regarding teacher preparation provider effectiveness data. The policy indicates that the Department will review and report to BESE effectiveness data for each approved provider offering Mentor teacher or Content Leader training.

By no later than December 1, 2019, and biannually thereafter, the LDOE will review and report to BESE **effectiveness data** of each approved provider offering Mentor teacher or Content Leader training. Effectiveness data will include **Louisiana Mentor Teacher Assessment Series or Louisiana Content Leader Assessment Series passage rates** and may include additional information. Based upon these results, BESE may require an improvement plan or may discontinue the provider's ability to recommend candidates for Mentor teacher or Content Leader certification.



- Elementary Math Mentor
- Elementary Non-Departmental Mentor
- Elementary Universal Mentor
- Secondary ELA Mentor
- Secondary Math Mentor
- Universal Mentor





*This report does not include participants that are now eligible based on the July 2021 Mentor policy updates. Those updates include reducing the number of required Mentor assessments to two.

For this report, Content Leader participants must have passed five assessments. This report includes individuals that have completed one of the following Content Leader Distinction Pathways:

- ELA Content Leader
- Math Content Leader
- Science Content Leader

Overview of Training Provider Effectiveness Findings

- Total Mentor and Content Leader candidates enrolled between 8/1/2018-7/31/2021: 838
- Of the 838 educators enrolled between 8/1/2018-7/31/2020, 349 completed training requirements to become a certified Mentor or Content Leader.
- Of the 838 educators enrolled between 8/1/2018-7/31/2020, 194 earned a passing score on the assessments based on the requirements at the time of their training state date.
- Based on June 2021 Mentor Policy Updates, 64 enrolled Mentors are now eligible for the ancillary Mentor Certificate.
