**ORDER**

IT IS FURTHER ORDERED that Cindy Barnes admit and cooperate with representatives of the Department of Children and Family Services at any reasonable date and hour for the sole purposes of determining her compliance with the Child Care Facilities and Child-Placing Agencies Licensing Act and the terms of this Order.
