ORDER

This matter came on for hearing the fifth day of May, 2011 on the State's request to reconsider its request for a preliminary injunction to block the unlicensed operation of a child day care facility. At the time of the initial hearing the Court was awaiting the results of the defendant's administrative appeal of a risk evaluation panel's hearing. Since that time, the administrative appeal has upheld the Department's finding, and all administrative and appeal rights with respect to that finding have now been exhausted or abandoned. The Court having this new evidence before it, and finding that the State has made out a *prima facie* case that it is entitled to the relief sought, therefore

IT IS ORDERED that a preliminary injunction issue, without bond, directed to defendant Deborah Baldwin-Stevenson, and enjoining, restraining, and prohibiting defendant, together with her officers, agents, employees, representatives, and all others acting at her direction or on her behalf, from operating a child day care facility without first having obtained a valid, current license from the Department of Children and Family Services, legal successor agency to the
