ORDER

This matter was scheduled for hearing on the State's request for a preliminary injunction for April 8, 2011. Prior to hearing the parties reached an agreement and desired that it be made the Order of this Court. Considering the verified pleadings and the consent of the parties and their respective counsel the Court is of the opinion that the Consent Order conforms to the law and evidence. Therefore, by consent of both parties,

IT IS ORDERED that a preliminary injunction issue as requested, without bond, directed to defendant LINDA DESSELLE, enjoining, restraining, and prohibiting her, together with her officers, agents, employees, representatives, and all others acting at her direction or on her behalf, from operating a child day care facility without first having obtained a valid, current license from the Department of Children and Family Services.

IT IS FURTHER ORDERED that Ms. Desselle pay statutory fines as provided in La. R.S. 46:1421 in the amount of TWO THOUSAND FIVE-HUNDRED DOLLARS (\$2,500.00) for operating a child day care facility without a license;

IT IS FURTHER ORDERED that the above statutory fines be suspended, contingent upon defendant's future compliance with all terms of this Consent Order, and upon her payment of court costs in the amount of one hundred fifty dollars (\$150.00);

IT IS FURTHER ORDERED that the State shall not pursue further fines or penalties against defendant so long as Ms. Desselle complies with all terms of this Consent Order; and that any future fines or penalties may be sought only upon a showing, after contradictory hearing, that defendant has violated one or more terms of this Order;

IT IS FURTHER ORDERED that Ms. Desselle may, consistent with the law and with the terms of this Order, provide care and supervision for not more than six children (Ms. Desselle's
