**CONSENT ORDER**

This matter was set for a hearing on the State's request for a preliminary injunction to block the operation of an unlicensed child day care facility. Prior to the hearing the parties reached an agreement, stipulating to the issuance of a permanent injunction in the form requested, and stipulating that Ms. Richard has extended her cooperation to the Department in resolving this matter, and further stipulating that the Department waive pursuit of the statutory fines and penalties, contingent upon Defendant's future compliance with the terms of this Order.

**THEREFORE,**

**IT IS ORDERED** that a permanent injunction issue, without bond, directed to Monique Richard, and preventing her, her officers, agents, employees, representatives, and all others acting at her direction or on her behalf, from operating a child day care facility without first having obtained a valid, current license from the Department of Children and Family Services, all costs to be assessed against Defendant;

**IT IS FURTHER ORDERED**, that Defendant Ms. Richard, cooperated fully with inspectors from the Department of Children and Family Services in verifying compliance with the terms of this Order, including but not limited to admitting said inspectors during all reasonable dates and hours for the purposes of verifying the number of children present and their relationship to Defendant.

That should she desire to provide care and supervision for more than seven children unrelated to her that she will obtain a valid, current license from the Department of Children and Family Services prior to doing so;

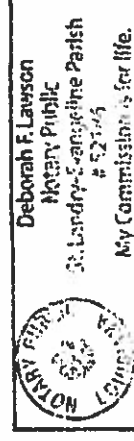
That she understands that no statutory fines or other penalties will be imposed so long as she complies with the terms of this consent order;
