CONSENT ORDER

This matter was set for hearing for May 10, 2011 on the Department of Children and Family Services ("Department")'s request for a preliminary injunction. Prior to hearing the parties reached a consent agreement and desired that it be made the judgment of this court. The Court being satisfied that the Order is entered into freely and voluntarily by both parties, appearing through Counsel, it being stipulated that this Order is in no way an admission of wrongdoing by Roberts United Methodist Church, Inc., nor an admission that the Department is likely to establish a *prima facie* case that it is entitled to a preliminary injunction, therefore

IT IS AGREED, AND SO ORDERED, that a preliminary injunction issue, without bond, directed to defendant Roberts United Methodist Church, Inc., and enjoining defendant, together with its officers, agents, employees, representatives, and all others acting at its direction or on its behalf, from operating a child day care facility without a valid, current child day care license;

IT IS FURTHER ORDERED, that defendant Roberts United Methodist Church, Inc. cooperate fully with inspectors from the Department of Children and Family Services in verifying compliance with the terms of this Order, including but not limited to admitting said inspectors during all reasonable dates and hours for the purposes of verifying the number of children present and their relationship to defendant.


