CONSENT ORDER

This matter was set for hearing the thirty-first day of May, 2011. Prior to hearing the parties reached an agreement and desired that it be made the order of the Court. Defendants agreed to issuance of the preliminary injunction as requested, offering the Department of Children and Family Services documentation that their facility closed shortly after being directed to do so, and the Department agreed to waive the statutory fines and penalties contingent upon future compliance with this Order. The Court being satisfied that the Consent Order conforms to the law and verified pleadings, therefore,

IT IS ORDERED that a preliminary injunction issue, without bond, directed to defendants Strong Tower Christian Center, Patricia A. Moore, Levi Kinchen, and Tina Moore, enjoining them, their officers, agents, employees, representatives, and all others acting at their direction or on their behalf, from operating a child day care facility without first having obtained a valid, current license from the Department of Children and Family Services.


