#### CONSENT ORDER

IT IS FURTHER ORDERED, that Defendant, Yvette Imbraguglio, cooperate fully with inspectors from the Department of Children and Family Services in verifying compliance with the terms of this Order, including but not limited to admitting said inspectors during all reasonable dates and hours for the purposes of verifying the number of children present and their relationship to Defendant at the facility.
