SCP Online Application Opens	February 3, 2025
SCP Online Application Closes	March 7, 2025
Deadline for Families to submit all Documentation to Schools	March 14, 2025
SCP Award Notification Letters to Families	April 29, 2025
SCP Summer Transfer Window Opens	June 9, 2025
SCP Summer Transfer Window Closes	July 18, 2025





2025-2026 Application Timeline

2025-2026 School Choice Scholarship application opens on February 3, 2025.

- 1. Access the <u>online application</u> on the LDOE website.
 - a. The link will be active **February 3, 2025**.
- 2. All online applications must be completed by March 7, 2025.
- **3. New Applicants only:** Submit all eligibility documents **to the first choice school** by **March 14, 2025.**
- 4. Schools have until March 21, 2025 to upload a verified demand report to the FTP.
- 5. 2025-2026 award notifications from the Louisiana Department of Education (LDOE) will be sent to families by **April 29, 2025.**

*Failure to meet these deadlines will result in the application being marked incomplete and/or removal of the Scholarship award.





Application



Application

In order to be eligible for an award, students must meet the following criteria:

- Have an exceptionality of autism, intellectual disability, brain injury, development delay, other health impairment, emotional disturbance, or specific learning disability.
- Be evaluated by the local school district and have an IEP or a district-created service plan.

Families will be required to provide copies of the IEP or district-created service plan along with proof of residency to first choice school listed on the application.

Continuing students must reapply in order to maintain their award for the upcoming school year.





Application

All applications must be submitted by March 7, 2025.

- **New Applicants only:** Families must submit all eligibility documents to their first choice school by **March 14, 2025**.
- Families will be required to submit copies of the IEP or district-created service plan along with proof of residency during the completion of the application.
- Continuing students **are not required** to provide eligibility documentation.





Application Process



Application Process

Applying for a School Choice Program is a two-step process.

- **Step 1:** Complete the online application using the LDOE website.
- **Step 2:** Submit the student's IEP/district provided services plan and residency verification to the first choice Scholarship school.





Application Process

The LDOE will attempt to place as many applicants as possible at their preferred school choice.

- Not all applying students are eligible.
- Demand for some schools and/or grades may be greater than the availability.
- State funding determines the final number of awards made.

Submitting Your Application: Eligibility Check

If a student does not meet the eligibility criteria, families will receive the following message:

Sorry, this student is not eligible to participate in this program.

Applicants must have an IEP or district provided service plan, must be eligible to attend any Louisiana public school, and must have at least one of the listed exceptionalities to quality.



New Applicants - Required Documentation

Families applying for **NEW** students must provide the following eligibility documents to your first choice scholarship school by March 14, 2025:

- 1. Copy of student's current Individualized Education Program (IEP) or district-provided service plan
- 2. One proof of residency documentation. Acceptable documents to verify residency include one of the following:
 - Rental agreement or mortgage statement
 - Landline telephone bill
 - Cable or internet service bill
 - Sewerage or water bill
 - · Electricity or gas bill
 - A current property tax notice
 - Official Letter from a Government Agency such as the Department of Children and Family Services (DCFS) or Department of Health and Hospitals (DHH)

<u>Please note</u>: Documentation must be in the parent and/or guardian's name and must match the student's address listed on the application.

Continuing students do NOT need to provide eligibility documentation.

- New applicants to the program will be asked to provide the following:
 - A copy of their IEP or district created service plan.
 - At least one proof of residency document.
 - All documents must be current and should match with the student's address listed on the application.
 - The person listed on this document must be the parent/adult responsible for the student.
- All documentation must be submitted to your first choice school.
