## Charter School Performance Compact: School Bus Safety

Charter school boards may be required by their authorizer to provide free transportation for any student within the jurisdictional boundaries of the local board if the student resides more than one mile from such school.

Boards wishing to implement their own transportation system instead of contracting with a bus operator should refer to Bulletin 119 - Louisiana Transportation Specifications and Procedures, for bus and employee requirements.

Exemptions: Type 2 charter schools not providing transportation and schools wishing to reimburse students for transportation (i.e. issuing tokens for public transportation)

#### **Bus Safety Requirements**

Warning Signals	Amber and red flashing warning signals must be used for student loading and unloading.	
Location	Buses must stop in the right traffic lane on a non-intersection part of the street.	
Opening of Doors	Drivers must ascertain that traffic has stopped and then open the door for entrance or exit of students.	
Railroad Crossings	Buses should stop no closer than 15 feet in front of the rail and open the service door to listen and look for approaching engines, trains, or train cars.	
Maximum Bus Speeds	55 mph on highways, 35 mph on streets	
Cell Phone Usage	No driver shall use a cell phone while driving a school bus except in emergency situations.	
Bus Capacity	The number of students per bus should not exceed the bus manufacturer's capacity limit.	
<b>Emergency Exits</b>	Aisles must be clear and doors and emergency exists must remain unobstructed at all times.	
Student Behavior	Students should remain seated with hands, arms, and heads inside the bus at all times, unless in emergency situations or when the bus it as a complete stop.	
Students with IEPs	Must provide school bus service for students with disabilities as indicated in the student's IEP. The IEP may specify "curb-to-curb" or "door-to-door" services. It may also require a bus attendant.	

### **Bus Safety Best Practices**

While not required by statute, schools should implement a transportation policy that includes:

- Student bus behavior expectations that align with the school's class behavior expectation
- Procedures for handling students whose parent is not at the bus stop
- and students
- Procedure for allowing parents and students to notify the school of bus issues
- Bus driver behavior expectations
- Clearly communicated bus stop locations and times with parents Communication procedures between the bus operator, the school, and parents in the event of an emergency situation
